MOTION FOR MODIFICATION

The Illinois Environmental Protection Agency ("Illinois EPA") hereby files this Motion for Modification pursuant to Section 101.520 of the regulations of the Illinois Pollution Control Board ("Board"), 35 Ill. Adm. Code 101.520.

- On December 18, 2023, the Illinois EPA received a request from Sunrise FS Havana (Log number TC-151222) for an Illinois EPA recommendation regarding the tax certification of water pollution control facilities pursuant to 35 Ill. Adm. Code 125.204.
- On December 20, 2024, the Illinois EPA filed its Recommendation, which recommended that the Board issue the requested tax certification.
- 3. On January 9, 2025, the Board issued the tax certification for the agrichemical containment structures that had been identified in the Illinois EPA's Recommendation.
- 4. Subsequent to the Board's Order of January 9th, the Illinois EPA was contacted by Sunrise FS regarding Illinois EPA's failure to include one of the requested facilities in its Recommendation; specifically, the Illinois EPA Recommendation did not include: "a bulk dry fertilizer storage building measuring 120 ft. (width) x 208 ft. (length)."
- The Illinois EPA has confirmed that this omission was an error on its part, and that the bulk dry fertilizer storage building may be considered a "pollution control facility" pursuant to 35 Ill. Adm. Code 125.200(a), with the primary purpose of eliminating, preventing, or reducing water pollution, or as otherwise provided in 35 Ill. Adm. Code 125.200, and is eligible for tax certification from the Board.

6. The Illinois EPA has corrected its technical review documents to include the bulk dry fertilizer storage building in its recommendation for tax certification, and has attached them to this Motion. The Illinois EPA has also attached all correspondence to and from Sunrise FS regarding the same.

WHEREFORE, the Illinois EPA moves that the Board modify its Order of January 9, 2025, to include the "bulk dry fertilizer storage building measuring 120 ft. (width) x 208 ft. (length)" in its tax certification.

A concrete truck loading area for the loading of bulk dry fertilizer transportation and application equipment (located in the truck loadout building) measuring 40 ft. (width) x 100 ft. (length) and the portion of the building over this operational containment structure.

A concrete operational containment structure for the blending of bulk dry fertilizer within the operational blender room (located in the truck load out building) 20 ft. (width) x 57 ft. 5 1/4 in. (length) and the portion of the building over this operational containment structure.





View of 34' x 152' loader transfer area of dry fertilizer storage building







(Entire building is called out on the Agrichemical Containment Permit although a 42′ 6^{1/4}″ x 20′ section is bath rooms and control room)



Dry Fertilizer Building Complex Cross Section — Depicts some of the exposed concrete operational areas that are not covered with a building structure and therefore, for simplicity purposes, were not mentioned in this addendum although they do qualify for certification. Examples of exposed concrete containment would be the concrete under the blending area and vertical elevator that lies between the dry building and the loadout building. In addition, the containment permit includes an off-site barge unloading containment area and a truck loading concrete containment area. These two concrete containment areas are not included in this certification application.

The dry fertilizer storage portion of the dry fertilizer building complex (120' x 208') qualifies for certification as a pollution control improvement by the authority of part 255.140 (a) of Title 8 Illinois Administrative Code, Chapter 1 Sub Chapter i. This determination has been previously affirmed by the Illinois Pollution Control Board in their PCB 24-23 Decision.

The operational containment sections of the subject dry fertilizer complex that are being proposed in this application as qualifying for certification as pollution control devices include the following:

- 1) The loader operational area (34' x 152"). This is the portion of the dry fertilizer complex adjacent to the dry fertilizer storage bins. The loader operational area is used to move dry fertilizer from the storage bins to a below ground level receiving pit which then in turn feeds a vertical elevator leg that moves the dry fertilizer to outside overhead holding bins.
- 2) The truck loading portion of the building complex (60' x 120'). This is the area where blended dry fertilizer is loaded from one of the four overhead holding bins into transportation trucks and/or application equipment.
- 3) The Operational Blending room adjacent to the truck loadout area that measures 20'x 57' 5 %". This area is a special blending area used to blend specialized ingredients in with the standard dry fertilizer formulations.

The total of these three operational areas is 13,518 square feet.

Section 255.140 of Title 8 of the Illinois Administrative Code states, in part, "Dry fertilizer materials shall be stored and handled in a manner to prevent pollution by minimizing losses to the air, surface water, underground water or subsoil," and containment devices or structures may include "enclosing handling areas" (Section 255.140(d)4. Enclosing the subject's operational containment areas of the dry fertilizer building meet the containment requirements as stated.

To further illustrate that the primary purpose of the building is for pollution control consider the following: If the subject operational areas were curbed with a 6" concrete curbing and sloped exits, then an unroofed operational area of the subject would contain a 6" rain event which is equivalent to a 50-year 24-hour storm. This would be the minimum requirement of an expose concrete containment area as stated in 255.80 b)(1). The following table calculates the volume of rain that a 6" rain event would accumulate on the subject secondary containment with no roof.

Dry Containment Area	Volume per inch of rain	Volume, 25-Yr. Rain (6")
13,518 sq. feet	8,426 gal ((13,518 x 7.48)/12)	50,557 gallons

The subject dry fertilizer operating areas were designed to be enclosed. If the operating areas were not enclosed with a building and the operational areas were exposed to the elements, regulations would require a pollution containment system with a minimum storage capacity of 50,000 gallons.

Without the building covering the dry fertilizer operational areas, a 250,000-gallon tank would be required to store enough rinsate to accommodate 80% of the rain that occurs during the growing season in Mason County. (See exhibit B). Over a 20-year period the combined cost of 1) constructing such a holding tank and then 2) truck spraying the accumulated rinsate on fallow or bare fields would more than double the cost to mitigate

rainwater runoff compared to the cost of a building to cover the area. See "Calculating the Cost of Rinsate Disposal Without Building" (Exhibit B). The cost to mitigate rinsate disposal without a building covering the operational area would exceed 200% of the cost of a building. Therefore, the building over the dry fertilizer operational areas has the primary purpose of pollution control by eliminating, preventing, or reducing air or water pollution.

Operation of an existing reinforced concrete operational containment structure measuring 42' (width) x 70' (length) x 0.58' (depth) with a total design capacity of 930.0 cubic feet (ft.3). The floor shall slope to a series of three sumps, two (2) sumps measuring 2' (diameter) x 2.5' (depth) and one (1) sump measuring 2' (width) x 4' (length) x 2.5' (depth) to facilitate the collection and recovery of all escaped product and/or agrichemical wastewater. All recovered effluent shall be transferred to a transportation or application vehicle for immediate reuse with a manually activated sump pump. Segregation shall be performed based upon the applicable target crop and label use. All loading of bulk liquid agrichemical transportation and application equipment shall be performed upon the herein permitted structure. This structure shall be referred to as OC-1.

Operation of an existing welded steel operational containment structure measuring 9' (width) x 14.5' (length) x 0.5' (depth) with a total design capacity of 65.3 cubic feet (ft.3). The floor shall slope to a single sump measuring 1.5' (diameter) x 1' (depth) to facilitate the collection and recovery of all escaped product and/or agrichemical wastewater. All recovered effluent shall be transferred to a transportation or application vehicle for immediate reuse with a manually activated sump pump. Segregation shall be performed based upon the applicable target crop and label use. Bulk liquid fertilizer transfer pumps shall be located within the herein permitted structure. This structure shall be referred to as OC-2.

Operation of an existing welded steel operational containment structure measuring 6' (width) x 6' (length) x 0.5' (depth) with a total design capacity of 18.0 cubic feet (ft.3). The floor shall slope to the lowest elevation to facilitate the collection and recovery of all escaped product and/or agrichemical wastewater. All recovered effluent shall be transferred to a transportation or application vehicle for immediate reuse with a manually activated sump pump. Segregation shall be performed based upon the applicable target crop and label use. Bulk liquid fertilizer transfer pumps shall be located within the herein permitted structure. This structure shall be referred to as OC-3.

SECONDARY CONTAINMENT STRUCTURE

Operation of two (2) existing welded steel secondary containment structures, each measuring 95' (diameter) x 8' (height), which shall be interconnected by a 3' (diameter) x 70' (length) steel transfer pipe, with a total design capacity of 85,224.0 cubic feet (ft.3). The floor shall slope to one (1) of two (2) sumps, each sump measuring 2' (diameter) x 0.5' (depth) to facilitate the collection and recovery of all escaped product and/or agrichemical wastewater. All recovered effluent shall be transferred to a transportation or application vehicle for immediate reuse with a manually activated sump pump. Segregation shall be performed based upon the applicable target crop and label use. Bulk liquid fertilizer shall be stored within the said structure.

Operation of an existing bulk dry fertilizer storage building measuring 120' (width) x 208' (length) with an estimated total storage capacity of 25,000 tons. The structure is composed of three (3) storage bins (one (1) bin measuring 74' (width) x 120' (length) with an estimated storage capacity of 8,000 tons, one (1) bin measuring 40' (width) x 120' (length) with an estimated storage capacity of 5,000 tons, one (1) bin measuring 94' (width) x 120' (length) with an estimated storage capacity of 12,000 tons).

All bulk dry fertilizer shall be stored within the herein permitted structure.

Operation of an existing reinforced concrete operational containment structure measuring 14' (width) x 27' (length). The unloading of bulk dry fertilizer transportation and application equipment shall be performed upon the herein permitted structure.

- 1) I could not find on my page 8, that is attached, the mention of a 60' x 120' measurement for the truck load out building. The correct dimension should be 40' x 100' as mentioned in item 2 on page 8 plus an additional 20' of width for the operational area cited in #3 on page 8.
- 2) The adjacent additional 20' of building width is mostly an operational blending area and would qualify for certification. The break room, bath rooms and the electrical portion of the 20' width (20' x 42' 6 1/4" would normally not qualify for certification, See Figure 7, page 6). As noted in figure 7 the entire 60' x 100' of the truck loadout building which includes the adjacent 20' of operational area is called out as an operational containment structure in the Agrichemical Containment Permit in paragraph 9 on page 12.

The dry fertilizer storage portion of the dry fertilizer building complex (120' x 208') qualifies for certification as a pollution control improvement by the authority of part 255.140 (a) of Title 8 Illinois Administrative Code, Chapter 1 Sub Chapter i. This determination has been previously affirmed by the Illinois Pollution Control Board in their PCB 24-23 Decision .

The operational containment sections of the subject dry fertilizer complex that are being proposed in this application as qualifying for certification as pollution control devices include the following:

- 1) The loader operational area (34' x 152' =5,168 SF). This is the portion of the dry fertilizer complex adjacent to the dry fertilizer storage bins. The loader operational area is used to move dry fertilizer from the storage bins to a below ground level receiving plt which then in turn feeds a vertical elevator leg that moves the dry fertilizer to outside overhead holding bins.
- 2) The truck loading portion of the building complex (40' x 100'=4,000 SF). This is the area where blended dry fertilizer is loaded from one of the four overhead holding bins into transportation trucks and/or application equipment.
- 3) The Operational Blending room adjacent to the truck loadout area that measures 20'x 57' 5 %" (1,150 SF). This area is a special blending area used to blend specialized ingredients in with the standard dry fertilizer formulations.

The total of these three operational areas is 10,318 square feet.

Section 255.140 of Title 8 of the Illinois Administrative Code states, in part, "Dry fertilizer materials shall be stored and handled in a manner to prevent pollution by minimizing losses to the air, surface water, underground water or subsoil," and containment devices or structures may include "enclosing handling areas" (Section 255.140(d)4. Enclosing the subject's operational containment areas of the dry fertilizer building meet the containment requirements as stated.

To further illustrate that the primary purpose of the building is for pollution control consider the following: If the subject operational areas were curbed with a 6" concrete curbing with sloped exits, then an unroofed operational area of the subject would contain a 6" rain event which is equivalent to a 50-year 24-hour storm. This would be the minimum requirement of an expose concrete containment area as stated in 255.80 b)(1). The following table calculates the volume of rain that a 6" rain event would accumulate on the subject secondary containment with no roof.

The subject dry fertilizer operating areas were designed to be enclosed. If the operating areas were not enclosed with a building and the operational areas were exposed to the elements, regulations would require a pollution containment system with a minimum storage capacity of 40,000 gallons.

The page 8 that you are citing doesn't match up with the page 8 in my copy of the application. I have attached the page 8 that I have.

- 1) I could not find on my page 8, that is attached, the mention of a 60' x 120' measurement for the truck load out building. The correct dimension should be 40' x 100' as mentioned in item 2 on page 8 plus an additional 20' of width for the operational area cited in #3 on page 8.
- 2) The adjacent additional 20' of building width is mostly an operational blending area and would qualify for certification. The break room, bath rooms and the electrical portion of the 20' width (20' x 42' 6 1/4" would normally not qualify for certification, See Figure 7, page 6). As noted in figure 7 the entire 60' x 100' of the truck loadout building which includes the adjacent 20' of operational area is called out as an operational containment structure in the Agrichemical Containment Permit in paragraph 9 on page 12.

It would be the decision of IEPA whether or not to separate out the $20' \times 42' \cdot 6 \cdot 1/4''$ area from the total building area. This area makes up 14% of the $60' \times 100'$ building area.



Good Morning Keith,

I apologize as it does appear there was an oversight/confusion on my part regarding the inclusion of the dry fertilizer storage building (120' x 208'). We are in the process of working with our legal team to submit a revision to the board.

In my initial review of the application, I believe I got confused by the statement "operational containment sections of the dry fertilizer complex being proposed in this application" and included those 3 operational containment sections in the recommendation. I apologize for my miss understanding.

Prior to submitting my revision, I wanted to clarify another item that was not clear to me on the application. I noticed the drawing on page 5 shows a 14' x 27' outdoor unloading pad but did not see this mentioned in the text. Page 7 of the application states that for simplicity purposes exposed concrete operational areas were not mentioned/included in the application. I wanted to point out that this containment area/unloading pad did not receive certification and ask if you are seeking certification for this area?

Also, page 7 mentions another outdoor containment area under the blending area and vertical elevator located between the dry fertilizer building and the loadout building. Please indicate if you would like to request certification for this area as well. If you would like to request certification for this area, please provide dimensions and a drawing of this containment.

I will need to provide an updated recommendation to our legal team by next Wednesday (1/29/25) as we only have 30 days to amend the prior board decision.

Once again, I am sorry for the confusion.
