

HEARING OFFICER ORDER

On February 6, 2025, all parties appeared for a telephonic status conference. As background it was reported the City of Chicago hearing officer (City of Chicago, Department of Administrative Hearings, Environmental Division) issued his decision in the related matter on June 1, 2023. The City of Chicago appeal of the decision was reversed on August 16, 2024, in a proceeding before the Circuit Court of Cook County. The petitioner has appealed. Briefing should be completed by the end of March 2025. The petitioner will file an additional waiver of the statutory decision deadline to September 4, 2025.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 22, 2025, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, with the petitioner providing a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter.


