MINUTES OF REGULAR INFORMAL BOARD MEETING OCTOBER 12, 1971, 189 W. MADISON ST., CHICAGO, ILLINOIS

All Board Members were present.

After hearing oral argument on a stay motion in # 71-69, EPA v. Incinerator, Inc., the Board voted 4-1, Mr. Dumelle dissenting, to allow operation under limited conditions designed to reduce nuisance, pending a hearing November 1 on the adequacy of the company's program filed in response to the initial order. A transcript was taken and a written order adopted by the same vote.

After discussion the following cases were set for decision October 14: ##71-4, Fry Roofing Co. (SL); 71-19, Spartan Printing (DC); 71-44, US Industrial Chemicals (SL); 71-57& -58, Trojan-US Powder (DC); 71-109, Williamson Housing (SA); 71-125, Citizens Utilities (DC); 71-129 Edison (RK); 71-172 Gerdes (SA), 71-185, Argonne Devel. Co. (JD); 71-205 Dearborn Chemical (Chemed) (JD); 71-235 Texaco (DC); 70-35 Fox Valley Grease (DC); 71-253 Pena (DC); 71-203 Purdy (DC), in addition to cases already on the agenda for October 14.

After discussion Mr. Lawton agreed to prepare a draft opinion in # 71-78, Freeman Coal, approving the present program on condition of a penalty for delay; Mr. Kissel In 71-108, Modern Foundry, finding that compliance has been achieved and imposing a \$1000 penalty for delay; Mr. Aldrich in # 71-157, City of Silvis, approving the present program and imposing a \$1000 penalty for delay.

The Board approved 5-0 Mr. Lawton's proposed modification of the order in # 71-165, Iowa-Illinois, to correct a transcription error and Mr. Currie's proposed orders denying motions for stay in #71-154, Pyramid Mobile Estates, and for dismissal or transfer in # 71-234, Cobin.

A revised meeting schedule was adopted, providing for fewer meetings outside the Chicago area because of lack of citizen response and the burden of travel time to the Board.

Mr. Currie agreed to write in opposition to H.B. 3058, which would impose money fines for failure of the Agency or Board to act within the time allotted on variance or permit applications. Minutes and new cases were deferred until October 14. Mr. Currie agreed to inform the Danville Sanitary District in #71-28 that its progress report should be submitted in writing and that a hearing would be authorized only if necessary.

A discussion of the effluent and water quality standards proposals, ## R70-8 and R71-14, was scheduled for November 1.

After a discussion of administrative matters the meeting was adjourned.
