MINUTES OF REGULAR BOARD MEETING
JANUARY 30, 1973, CHICAGO ILLINOIS

All Board members were present.

Opinions and orders were adopted by the Board in the following cases by a vote of 3-0: ## 72-4, Lenz; 72-61, Denny & Simpson; 72-84, Custom Farm; 72-95, Halvorsen; 72-123, Livingston; 72-163, Beecher; 72-266, Washington; 72-303, Tuscola; 72-320, Central Soya; 72-414, -415, Armak; 72-434, Hanna and 72-440, Steele (opinion only); 72-397, Marquette.

Decisions in these cases were put over to Feb. 6: ## 71-326, Allied; 72-258, Bell & Zoller; 72-276, Aurora; 72-450, Olin.

An order reducing the penalty in #72-175, W. Frankfort was adopted by a vote of 3-0.

Motion to strike and dismiss in #72-403, Producers Mining was put over to Feb. 6.

A motion to withdraw a petition in #72-512, Brummel Woods was granted by a vote of 3-0. Mr. Lawton will prepare an order.

Discussion was held in #72-420, Pekin Lake and Mr. Dumelle agreed to prepare an opinion for decision Feb. 6.

Parties were present in #72-253, Olin, on a motion to rehear or modify the Board Opinion. The proceedings were transcribed. The parties were given until Feb. 2 for any further submissions and it was set for discussion Feb. 6.

In #72-462, Liberty Financial parties were present. The Board voted 3-0 to allow the variance as of March 1, 1973. Mr. Lawton will prepare the order.

After some discussion the Board voted 3-0 to deny the variance in #72-432, Penn. Mr. Lawton will prepare the order.

Marvin Medintz reported to the Board on #71-377, Freeman Coal and it was set for further discussion Feb. 14.

The Board adopted an opinion and order in #72-441, Western Ill. Power by a vote of 3-0.

In ##72-199,-238, Southern Illinois Power, it was noted that the reports had been filed as ordered. Mr. Lawton will prepare an order for Feb. 6.

Variance in #72-429, Montebello was granted 3-0. Mr. Dumelle will prepare an order.

A motion to cancel the hearing and grant the variance in #72-500, Decatur was granted 3-0. Mr. Lawton will prepare the order.

In new cases these actions were taken: ## 73-23, Incinerator, hold for EPA recommendation; 73-24, Baumann, dismissed by a vote of 3-0; 73-25, Electric Energy, authorized for hearing; 73-26, Granite City, hearing authorized; 73-27, Univ. of Illinois, hold for EPA recommendation; 73-28, Housing Authority of Pulaski County, additional information will be requested, Mr. Henss to prepare an order.

The Board discussed the matter of Phosphorus Standards and Mr. Lawton said he would request a proposal from the Agency.
