MINUTES OF REGULAR BOARD MEETING
FEBRUARY 6, 1973, CHICAGO, ILLINOIS

All Board members were present.

Opinions and orders were adopted by a vote of 3-0 in the following cases:
71-199,-238, Southern Ill. Power; 72-256, White Brothers; 72-258, Bell & Zoller; 72-276, Aurora; 72-420, Pekin Lake; 72-450, Olin.

Discussions in ## 71-326, Allied Chemical and 72-63, -153, Truax and Consolidation were put over to Feb. 7.

Decision in ## 72-172,-73-5, Van Der Molen was put over to Feb. 21.

Decisions in ## 72-268, Lemkuhl and 72-426, Shawnee were put over to Feb 14.

Motion to strike and dismiss in # 72-403, Producers Mining was ordered taken with the case.

In ## 72-414,-415, Armak Mr. Henss read a concurring opinion that he will file disagreeing with the Board Opinion in that case, but agreeing with the order.

A motion to withdraw petition in #72-480, Waukegan was allowed by a vote of 3-0. Mr. Lawton will prepare an order.

Variance in #72-455, Godfrey was allowed by a vote of 3-0. Mr. Lawton will prepare an order.
