MINUTES OF REGULAR BOARD MEETING FEBRUARY 27, 1973 CHICAGO, ILLINOIS

All Board members were present.

Variance was granted by a vote of 3-0 in #72-499, Stone. Mr. Lawton will prepare an order.

Parties were present in ## 72-172, 73-5, Van Der Molen. After some discussion, the Board voted 3-0 to reject the stipulation filed in ##72-172, Van-Der Molen and set a further hearing on the complaint. Variance petition in ###73-5, Van Der Molen was withdrawn. Mr. Lawton will prepare an order.

It was noted that a waiver had been filed to March 8, 1973 in #72-477, G.E. Mr. Dumelle will prepare an opinion for decision March 8.

An order on motion for reconsideration was adopted 3-0 in # 72-180, Mystik Tape.
