Minutes of Regular Board Meeting March 22, 1973 Chicago, Illinois

All Board members were present.

Mr. Lawton announced a change in meeting schedule. The meeting scheduled for Thursday, April 19, 1973 will be held on Tuesdat, April 17, 1973.

Opinions and Orders were adopted in the following cases by a vote of 4-0: ##71-370, Aluminum Processing; 71-377, Freeman Coal; 72-52, 48-Insulations; 72-172, Van Der Molen; 72-181, Cerro Copper; 72-284, - 73-36, Ferguson and Lange; 72-403, Producers Mining; 72-467, M & W Disposal; 72-514, E. St. Louis; 72-517, Olin Corporation; 73-22, Chicago Grey Iron; and 73-56, Hahn.

An interim Order was adopted by a vote of 4-0 in #72-350, Commonwealth Edison. Mr. Dumelle will prepare the Order and an Opinion for March 29, 1973.

Motion for clarification in #71-343, North Shore Sanitary District was put over to March 29, pending receipt of responses from all parties.

Motion to dismiss in #72-242, International Harvester, was put over to March 29, for discussion.

A motion to withdraw petition in #72-387, Argonne, was granted 3-0. Mr. Lawton abstained from taking part in the decision or discussion. Mr. Henss will prepare an Order.

An Opinion and Order on motion for reconsideration in #72-396, Sauget was adopted 4-0.

A motion to withdraw petition in #73064, U. S. Army was granted 4-0. Mr. Lawton will prepare an Order.

A motion to dismiss in #72-464, Citizens v. Joliet was put over to April 5 pending receipt of a response by the Agency.

In new cases: ##73-114, M.M. Rosenberger, a hearing was authorized but petitioner will be asked to submit an amended petition. Mr. Lawton will prepare an Order; 73-115, Marquette Cement, ordered held for EPA recommendation. A partial amendment to the Water Quality Standards (#R72-4) was adopted by a vote of 3-0. Mr. Seaman abstained from taking part in the decision.

An application for permit to build a breakwater by Waukegan Port District was approved by the Board by a vote of 4-0.

Mrs. Wiley reported to the Board on budget matters for FY74.

The Board dismissed court reporting costs for variance petitions and court reporting services.

The Board authorized solicitation of bids and decided to invite quotes from court reporting firms for court reporting services for FY74.

Oral argument was heard by the Board in #71-386, - 72-386, Mpnarch Foundry. The proceedings were transcribed.
