Minutes of Regular Board Meeting  
May 17, 1973 Chicago, Illinois

All Board Members were present.

Mr. Lawton announced that our budget for FY74 had been approved by the House Appropriations Committee. He also asked that the Board Members review the index to published Opinions for final approval to publish.

An opinion in #72-410, Donnelley was adopted by a vote of 4-0. This was in support of an order entered and adopted on May 10, 1973. An opinion and order was adopted in #72-472, Donnelley by a vote of 4-0.
