MINUTES OF REGULAR BOARD MEETING  
May 31, 1973 CHICAGO, ILLINOIS

All Board Members were present.

Opinions and Orders were adopted by a vote of 4-0 in: ##72-65, Archdale; 72-145, Chicago Block; 72-246, Lewis & Clark; 72-507, Nutty; 72-510, Marion; 73-26, Granite City ; 73-71, Johnson & Johnson.

An Opinion was adopted in #72-350, Commonwealth Edison by a vote of 3-1. Mr. Dumelle dissented.

The Board granted variances as per E.P.A. recommendations in the following: ##73-124, Mt. Olive; 73-127, Waverly; 73-129, Anna State Hospital; 73-132, Norris City; 73-133, Harrisburg; 73-153, White Hall; 73-154, Illinois State Farm; 73-170, Sorento. The vote was 4-0. Motion to modify variance in #72-401, Sherwin-Williams was ordered held to June 7 pending receipt of Agency Response. The Board adopted an order granting the variance until June 7, 1973 by a vote of 4-0; Mr. Lawton will prepare the order.

Also put over for discussion and possible decision were: ##72-185, -327, Spinney Run Farms; 72-242, International Harvester; 73-12, -35, Mississippi Lime; 73-59, Metro Disposal; 73-144, Martis.

The Board vote 4-0 to continue the matter of #R71-24, Beverage Containers generally to August 1, 1973. Mr. Lawton will prepare an Order.

Mr. Henss' proposed final draft on #R73-5, Open Burning Amendments was not adopted by a vote of 3-1. Mr. Henss only voted in favor of it. Mr. Seaman proposed that it be adopted minus paragraph 1 but failed to be seconded. Mr. Lawton proposed that the Agency proposal of May 22, 1973 be adopted minus paragraph 2 but failed for want of a second. Mr. Dumelle made a motion that the population figure in the open burning regulations be changed from 2,500 to 5,000 but it failed for want of a second.

A petition for amendments to the Air Regs. filed by Marathon Oil Company was ordered held pending receipt of a response from the Agency.

Proposed amendments to Water Quality Standards and Solid Waste Regulations were put over to June 7 for discussion.
