MINUTES OF REGULAR BOARD MEETING  
June 14, 1973 Chicago, Illinois

All Board Members were present save Mr. Seaman.

The Board approved the court reporting contract entered into with Leon Golding and Associates for FY74 by a vote of 3-0.

By a vote of 3-0, the Board adopted opinions and orders in the following cases: ##72-413, Ocoya Stone; 73-15, Exchange Bank; 73-48, Continental Bldg.; 73-80, G.E.; 73-86, Galesburg; 73-144, Martis; 73-159, Locke Stove; 73-203, Trepanier.

A motion for extension of time to file program in #72-188, Ashland was granted 3-0; Mr. Lawton will prepare an order.

Motion to modify was granted in #72-200, DuQuoin by a vote of 3-0; Mr. Lawton will prepare an order.

In #72-316, Ill. Central R.R., motion for oral argument or to file briefs was granted as to briefs by a vote of 3-0; Mr. Henss will prepare an order.

Motion to dismiss in #73-89, Northlake v. Elmhurst was put over pending receipt of response from all parties. The Board adopted an order to that effect 3-0 and Mr. Lawton will prepare the order.

The Board voted 3-0 to hold a motion to grant without hearing in #73-239, Mobil until receipt of E.P.A. Recommendation.

Variances were granted in ##73-131, Carrier Mills; 73-162, Ashley; 73-207, Eldorado. The vote was 3-0, Mr. Dumelle will prepare orders with an opinion to follow.

A hearing was authorized on a proposed amendment to the Air Regulations filed by Marathon Oil Co. by a vote of 3-0; Mr. Lawton will prepare an order.

In #R72-5, Solid Waste Regulations, the Board authorized a proposed final draft for publication in the next Newsletter.

The Board adopted regulation in #R72-18, Farm Grain Dryers as modified since publication in Newsletter # 65 by a vote of 3-0. The Board also voted to file with the Secretary of State's Office on an emergency basis.

A motion for oral argument in #72-464, Citizens v. Joliet and Uniroyal was granted and set for June 28, 1973 at 3:00 P.M.

Discussions in ##R70-17, DuPage and R72-4, -8, and R73-1, 3 and 4, Water Quality Amendments were put over to June 21.

The Board discussed R72-2, Noise Regulations and approved a proposed final draft for publication as modified in the next Newsletter.
