MINUTES OF REGULAR BOARD MEETING July 19, 1973 Chicago, Illinois

All Board Members were present.

Mrs. Valoise Fawcett presented a letter of request for information on obtaining a sewer permit. The Board referred her to proper variance procedure.

The Board adopted an Opinion and Order in #72-311, Litchfield by a vote of 3-0. Mr. Henss was not present for the vote.

Opinions and Orders were adopted in the following cases by a vote of 4-0: ##73-166, Anderson; 72-394, Hillsboro; 72-483, Columbia Quarry; 73-74, Reliable Armature; 73-71, Johnson & Johnson, Opinion only.

In #73-202, Shabbona Park, Mr. Fred Garrott appeared and presented a further statement on behalf of Shabbona Park. The matter was set for Decision July 26, 1973.

An Opinion and order granting a variance was adopted in #73-195, Baron by a vote of 3-1. Mr. Dumelle dissented.

Minutes of Board meetings held June 28 and July 12, 1973 were amended and approved 4-0.

Motion to dismiss in ##71-208, Martin and 72-328, Peabody was denied 4-0. Mr. Lawton will prepare the order.

Motion for stay of penalty was granted in #72-164, Aurora by a vote of 4-0. Mr. Lawton will prepare an order.

In #72-468, Elizabeth St. Foundry, motion for modification was allowed 4-0. Mr. Lawton will prepare an Order.

Motion for reconsideration in #73-59, Metro Disposal was put over for decision on July 26, 1973.

Renewed motion to dismiss in #73-83, Mobil Oil was denied 4-0. Mr. Lawton will prepare an order.

A motion as to the unconstitutionality of the Act with regard to penalties in #73-85, Allis-Chalmers was denied 4-0. Mr. Lawton will prepare an order.

Motion to strike the Agency recommendation in #73-215, Benj. Harris was denied 3-0. Mr. Dumelle will prepare an order. Mr. Lawton did not participate in the discussion or decision of the matter.

Motion to decide without hearing in #73-234, Community Unit Schools was granted 4-0. Mr. Lawton will prepare an order.

Motion to dismiss in #73-258, City of Sandwich was set for decision July 26, 1973.

Petition for interim variance in #73-263, Owens-Illinois was granted 4-0. Mr. Lawton will prepare an order.

In #73-252, People v. Stuart Oil, motion to dismiss was denied 4-0. Mr. Lawton will prepare an order.

Motion for stay of penalty was granted 4-0 in #72-51, CPC. Mr. Lawton will prepare an order.

A hearing was authorized in #73-251, J. R. Short Milling Co.

Decision on motions for stay by Steel Companies regarding the Air Regulations was set for July 26, 1973.

Since neither party appeared at a hearing in #73-165, Weissburg v. European Motor Sport, the case was dismissed 4-0. Mr. Lawton will prepare an order.

Attorney for Respondent in #72-241, Abam Bldg. appeared and requested Oral Argument. Decision whether or not to grant was put over to July 26, 1973.

Opinion and Order in #73-6, Texaco was adopted 4-0.
