MINUTES OF REGULAR BOARD MEETING
August 23, 1973 Chicago, Illinois

All Board Members were present.

Mr. Dumelle announced that appointment of two new members to the Board. Mr. Sidney Marder and Dr. Russell T. Odell. Mr. Marder was in attendance.
