Minutes of Regular Board Meeting
January 17, 1974 Chicago, Illinois

All Board Members were present.

An Opinion and Order was adopted in #73-426, Ashland by a vote of 4-1; Mr. Seaman dissented.

An Opinion and Order including these North Shore Sanitary District Variance Petitions was adopted by a vote of 5-0: #73-138, M. R. Smith; 73-453, Viti; 73-455, Anderson; 73-473, Kohn; 73-476, Goebelt; 73-479, Schack; 73-524, Bram; 73-526, Brenner; 74-7, Fitzgerald.

Attorney for Petitioner was present and waived 90 day time requirement to January 24, 1974 in #73-356, Lake Forest Hospital.

Motion to dismiss in #73-83, Mobil Oil by Petitioner was granted 5-0. Mr. Henss will prepare an order.

Motions to withdraw in #73-179, 73-180, Texaco were allowed 5-0. Mr. Marder will prepare an order.

An order on motion for reconsideration in #73-341, Barrett was adopted 5-0. Mr. Marder will prepare the order.

Motion to modify in #73-388, Armour-Dial was ordered held for the Agency Response.

Motion to dismiss in #73-417, Hinsdale was assigned to Mr. Henss for review.

Motion to strike in #73-509, Olin, was ordered taken with the case by a vote of 4-1. Mr. Marder dissented and Mr. Henss will prepare an Order.
