Minutes of Regular Board Meeting February 21, 1974 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##72-317, Arbor v. Motion for extension of time to pay penalty was denied 5-0 in ##73-55, 73-174, Eckrich & Kneip. Dr. Odell will prepare an order.

Motion for modification was granted 5-0 in #73-338, Winnetka. Mr. Dumelle will prepare an order.

The Board voted 5-0 to reconsider its vote of February 14, 1974 in #73-447, Near Ones v. Carlson to re-assign to another hearing officer. The motion to re-assign was then denied 5-0 and the Board ordered a hearing to be set in 60 days. Mr Henss will prepare an order.

Motion to reconsider in #73-492, Foreman was held to February 28. Mr. Dumelle will review and prepare a draft order.

Motion for default in #73-462, Interlake was discussed and put over to February 28. A waiver of time will be requested.

In #73-539, Reichhold Chemicals, motion for extension of time to file response to motion to dismiss was granted to February 27 by a vote of 5-0. A waiver will be requested. Mr. Dumelle will prepare an order.
