## ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting May 2, 1974 Chicago, Illinois

All Board Members were present except Mr. Marder who was taking an engineering examination.

The Board adopted orders on pending cases ordering hearings to be set in #72-276, Aurora; 72-516, Cooper. The vote was 4-0.

The Board adopted Opinions and Orders in the following cases by a vote of 4-0: ##73-42, -145, G. E. and Hotpoint; 74-10, Illinois Power; 74-61, Harrisburg; 74-62, Mt. Olive; 74-64, Ashley; 74-99, Eldorado; 74-100, Triple Oaks Water Co.; 72-309, Trilla.

An opinion and order was adopted in #73-532, Moss-American by a vote of 3-1, Mr. Henss dissented.

Motion to consolidate pending Alton Box Board cases (73-61, 74-5, and 74-51) was allowed by a vote of 4-0. Mr. Henss will prepare an order.

Motion to dismiss in #74-73, Will County Water Co. was allowed 4-0. Mr. Seaman will prepare an order.

Motion to dismiss cross-complaint, in #74-79, Glidden-Durkee was held pending clarification of the motion to dismiss by the Agency.

A motion to vacate order of dismissal in #74-83, Rutland v. Board of Supervisors was denied 4-0. Mr. Dumelle will prepare an order.

Hearing in #74-131, EPA v. Watts Trucking Service was ordered set not sooner than 45 days from the date of filing by a vote of 4-0. Mr. Henss will prepare an order. This was pursuant to a motion to continue.

In R72-2, Noise Regulations, motion for stay by Rockford Drop Forge, the Board voted 4-0 to ask parties to submit proposed orders. Mr. Dumelle will prepare an order.

Minutes of Board Meetings held April 18 and 25, 1974 were approved by a vote of 4-0.
