MINUTES OF REGULAR BOARD MEETING August 8, 1974 Chicago, Illinois

All Board Members were present save Mr. Henss who was on vacation.

An amendment to the Air Regulations (Chapter 2: Rule 103) was adopted under R72-18, Grain Dryers by a vote of 4-0.

Motion to amend in #71-355, Jacksonville was denied by a vote of 4-0, Mr. Dumelle will prepare an order. Petitioner was ordered to file as a new variance petition.

Motion to dismiss in #73-425, Barrington was assigned to Mr. Seaman to prepare a draft order for August 29.

Motion to incorporate record in ##73-460, 74-235, Stepan Chemical was denied by a vote of 4-0, Mr. Marder will prepare an order.

Motion to extend in #73-477, Tuck Industries was construed as a new variance petition assigned a new number and held for an Agency recommendation.

Application for non-disclosure in #74-140, Western Piece Dryers was granted a conditional non-disclosure status by a vote of 4-0. Mr. Seaman will prepare an order.
