MINUTES OF REGULAR BOARD MEETING
March 30, 1978 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: #77-112, Big Foot Packing; 77-296, American Development; 77-304, Village of Lyndon; 77-348, Hanover Park; 78-3, Algonquin; 78-6, Olin Corporation.

Verbal waiver of the 90 day decision date was received and a hearing was authorized in #78-9, Tri-County by a vote of 5-0.

Amendments to R73-11, -12, NPDES were adopted and a Board Order of December 20, 1977 affirmed by a vote of 5-0.

R75-10, Coal Refuse Burning Regulations were adopted by a vote of 5-0.

R77-16, Amendments to Board Procedural Rules and the Solid Waste Regulations were adopted by a vote of 5-0.

A Proposed Opinion and Order were adopted for publication and comment in R77-6, Ammonia Effluent Standards by a vote of 5-0.

Motion to Extend in #73-30, Hall was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for Reconsideration in #76-56, -220, Fox Valley Grease was denied by a vote of 4-0. Mr. Young abstained. Mr. Dumelle will prepare the Order.

Motion to Amend in #77-162, Watts Trucking was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to take Interlocutory Appeal in #77-167, Paxton Landfill was granted and briefing schedule set by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to Dismiss was granted by a vote of 5-0 in ##77-253, -267, Hemphill. Mr. Goodman will prepare the Order.

Motion to File Brief Instanter in #77-252, Wyoming was allowed 5-0.

Joint Motions for Stay were allowed by a vote of 5-0 in these cases: ##77-276, Zimmerman and 77-275, Korte. Mr. Dumelle will prepare the Orders.

Motion to amend in #76-276, Troy was denied and Order of March 16, 1978 affirmed by a vote of 5-0. Mr. Dumelle will prepare an Order.

An Amended Complaint was filed in #77-330, Guldan v. Palos Park. The Board voted 5-0 to affirm the earlier dismissal Order. Mr. Dumelle will prepare the Order.

An Objection was filed in #78-18, Lanning and the Board authorized a hearing.

Motion to Cancel Hearing in #78-25, Orland Trails was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to Dismiss #78-27, Kazlauskas, et al., was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to Amend #78-28, Rapid Liquid Waste was granted by a vote of 5-0. Mr. Goodman will prepare the Order.

Motion to Amend #78-29 Cannon was granted by a vote of 5-0. Mr. Dumelle will prepare the Order.

An Objection was filed in #78-67, Caterpillar Tractor and a hearing was authorized.

Amended Petition in #77-201, Commonwealth was accepted and hearing ordered to go forward.

Amended Petition in #78-51, Richland Foundry was authorized for hearing.

An Opinion and Order was adopted in #75-379, Tri-No Enterprises and #76-65, Starnes by a vote of 4-0, Mr. Young abstained.

A Supplemental Opinion on Economics was adopted in R75-4, Air Episode Revisions by a vote of 4-1, Mr. Werner dissented.

Metropolitan Disposal Company, hearing mandatory; 78-93, EPA v.
