MINUTES OF REGULAR BOARD MEETING
April 27, 1978 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 4-1, Mr. Dumelle dissented: #72-51, CPC (on remand); 75-468, Material Services.

An Opinion and Order was adopted in #77-179, Fox Valley Grease by a vote of 4-0, Mr. Young abstained.

Motion filed in #76-284, Farmington Development was construed as a new petition, additional information requested and 90 days for decision ordered to start from date of Order by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to withdraw in #77-42, Chapman was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for interlocutory appeal and for sanctions in #77-167 and 77-231, Paxton Landfill were denied by a vote of 5-0. Mr. Goodman will prepare the Order.

Motion to require et al in #77-280, Fairbury was denied by a vote of 5-0. Dr. Satchell will prepare an Order.

Hearings were cancelled in these cases and will be decided without hearing: #77-306, Shell Oil and 77-324, Peabody Coal.

Motion for rehearing was granted in #77-339, Cary by a vote of 5-0. Hearing was authorized and the 90 days for decision ordered to begin on April 27, 1978. Mr. Dumelle will prepare an Order.

Motion for sanctions in #78-37, Oregon was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Amended petitions filed in ##78-87, Dept. of Law Enforcement and 78-91, International Harvester were ordered held for Agency recommendations. Amended petition in #77-329, Exxon Corporation was ordered to hearing.
