MINUTES OF REGULAR BOARD MEETING May 11, 1978 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##77-174, Reichhold Chemicals; 77-178,-281, Koppers; 77-309, Commonwealth Edison; 77-319, Harden; 78-40, Village of Victoria; 78-58, Village of Auburn.

An Opinion in support of a previous Order was adopted in #78-25, Orland Construction Co. by a vote of 4-1, Mr. Young dissented.

A proposed Order was adopted for publication and comment in the matter of R74-2, R75-5, Sulfur Dioxide Regulations by a vote of 3-2. Mr. Young and Mr. Werner dissented.

A final Order was adopted in R75-11, Motor Racing Noise Regulations by a vote of 4-1. Mr. Young dissented.

Motion to vacate order in #76-150, Kankakee was denied by a vote of 5-0, Mr. Dumelle will prepare the Order.

On motion to schedule a hearing in #77-15, Abdnour the Board adopted an Order requesting that a hearing be scheduled. The vote was 5-0, Mr. Goodman will prepare the Order.

Motion to withdraw a motion previously filed in #77-59, Alton Box Board was granted by a vote of 5-0. Mr. Goodman will prepare the Order.

Motion to file counter-claim and motion to vacate order in #77-143, Giachini were denied by a vote of 5-0. Mr. Young will prepare the Order.

Motion for costs in #77-162, Watts Trucking was denied by a vote of 5-0. Mr. Dumelle will prepare the Order.

An Order was adopted in #77-203, Allied granting a motion to declare et al by a vote of 5-0. Dr. Satchell will prepare the Order.
