MINUTES OF REGULAR BOARD MEETING June 22, 1978 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##75-400, Abbott Labs; 77-136, Village of Sauget; 77-277, Mobil Oil; 77-317, U.S. Steel, Mr. Werner concurred; 78-21, Union Carbide, Mr. Werner concurred; 78-42, Electric Energy; 78-66, Illinois Power; 78-99, Amax Coal; 76-310 and 77-44, Interlake, Mr. Dumelle concurred.

A proposed Opinion and Order was adopted for publication and comment in R76-15, Livestock Waste Regulations Amendments by a vote of 5-0.

An Order was adopted in ##76-56 and 76-220, Fox Valley Grease asking the Hearing Officer to comment on a motion to correct record. The vote was 4-0, Mr. Young abstained. Mr. Dumelle will prepare the Order.

Motion for reconsideration in #76-150, Kankakee Utilities was denied by a vote of 5-0. Mr. Dumelle will prepare the Order.

An Order was adopted on a motion for modification in #77-153, Derby Meadows by a vote of 5-0. Mr. Young will prepare the Order.

Motion for reconsideration in #77-179, Fox Valley Grease was denied by a vote of 3-1. Mr. Young abstained and Mr. Werner dissented. Mr. Dumelle will prepare an Order.

Motion to set aside an Order in #77-275, Korte was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to set aside an Order in #77-276, Zimco was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for modification in #77-319, Harden was granted by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion for continuance in #78-50, NSSD was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

The Board decided that Mr. Dumelle should write a letter to the Dept. of Transportation regarding a motion filed for reconsideration in #78-114, Dept. of Transportation. Motion was held to July 6, 1978.

A motion to extend time for filing an amended petition and a motion to allow entry of appearance were granted by a vote of 5-0 in #78-115, Kelsey-Hayes. Mr. Dumelle will prepare an Order. Minutes

It was determined that no action was needed on a motion to strike an affidavit in #78-121, Storey.

No action was needed on #78-143, Rock Island, a motion for extension of time.

Notice of withdrawal of complaint was allowed in #78-13, Verva Rocke v. County of Cook et al and the case was dismissed by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motions to file recommendations in ##78-103, Zimco and 78-104, Korte were granted by a vote of 5-0. Mr. Dumelle will prepare the Orders.
