MINUTES OF REGULAR BOARD MEETING  
August 3, 1978 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##75-218, Epperson et al; 76-316, S. DuPage Auto; 77-82, Commonwealth Edison; 77-180, Armak (Opinion only); 77-279, Atwood Grain; 77-331, Board of Library Directors et al; 78-75, City of St. Francisville; 78-156, City of Peru.

An Order was adopted in #77-201, Commonwealth Edison by a vote of 4-1, Mr. Dumelle dissented.

##78-125, Belvidere and 78-148, Veteran's Home were dismissed since no amended petitions were filed. The vote was 5-0, Mr. Goodman will prepare the Orders.

A Proposed Opinion and Order was adopted in R76-17, Monsanto, Mercury for publication and comment by a vote of 5-0.

A Proposed Order was adopted in R76-16, Blasting Noise for publication and comment by a vote of 5-0.
