Minutes of Regular Board Meeting September 7, 1978 Chicago, Illinois

All Board Members were present save Mr. Young who was ill.

Opinions and Orders were adopted in these cases by a vote of 4-0: ##77-107, Ranch Oaks; 77-327, U.S. Steel; 78-49, Macomb Country Club; 78-71, Commonwealth Edison; 78-78, CIPS; 78-144, North Shore Sanitary District; R74-15,-16, Cyanide Regulations.

An Opinion and Order was adopted in #78-106, Chicago by a vote of 3-0, Mr. Dumelle abstained.

The Board voted 3-0 to accept an interlocutory appeal in #75-112, M.S.D., Mr. Dumelle abstained. Mr. Goodman will prepare an Order.

An Order was adopted in #77-162, Watts concerning an application for non-disclosure by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to close the record in #78-37, Oregon was denied by a vote of 4-0. Mr. Goodman will prepare an Order.

An Order was adopted in #78-38, Frye on an application for non-disclusure by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion for decision on pleadings was dismissed as moot in #78-106, Chicago by a vote of 4-0. Mr. Goodman will prepare an Order.

The Board entered an Interim Order in #78-114, Department of Transportation asking for additional information and a motion for reconsideration by EPA was held pending receipt. The vote was 4-0, Mr. Dumelle will prepare an Order.

Motion to amend in #78-121, Storey was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

In #78-124, Bloomingdale, motions to withdraw by these parties were granted by a vote of 4-0: Olympic Stain, Crichton's; Lyon Metal; Hoffer Plastics; Crete; Woodruff and Edwards; Burgess Metal; Kendall; and Solo Cup. Mr. Dumelle will prepare an Order.

Motion to dismiss in #78-132, Millstadt was denied by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to reconsider in #78-189, Illinois Power was denied by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion for extension in #78-194, Willowbrook was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for extension of time to respond to a motion for specification was granted in #78-197, B.F. Goodrich by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to continue in #77-237, Chrysler was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

An amended petition filed in #78-196, Norge was ordered held for an Agency Recommendation by a vote of 4-0.

An Interim Order was adopted in #78-61, Commonwealth Edison by a vote of 4-0.

In new cases these actions were taken by a vote of 4-0: ##78-231, Park Ridge Park District, dismissed, Order by Mr. Goodman; 78-241, Granite City Steel, hearing authorized; 78-242, Olin Corp., hearing authorized.

Alumax Extrusions; 78-236, EPA v. Kaney Transportation; 78-237, EPA vl Lennon Wall Paper; 78-238, EPA v. City of Plano; 78-239, EPA v. SCM Corp.; 78-240, EPA v. City of Wood Dale.

The Board voted 4-0 to change the regular meeting scheduled for October 5 to October 4 due to the Institute for Natural Resources conference being held on October 5.

All matter not disposed of as listed were ordered placed on an agenda for September 21 for possible consideration.
