MINUTES OF REGULAR BOARD MEETING
November 30, 1978 Chicago, Illinois

All Board Members were Present.

Opinions and Orders were adopted by a vote of 5-0 in these cases:
##77-15, Abdnour; 77-287, Industrial Coating (Interim); 77-344, First National Bank of DeKalb; 78-76, Everett Allen; 78-184, Homer Grain (Opinion only); 78-185, Hen House; 78-209, Jack Merkin; 78-242, Olin.

In #76-56,-220, Fox Valley Grease, a motion to dismiss was ordered taken with the case, motion for clarification granted and motion to require denied by a vote of 3-0, Mr. Young abstained. Mr. Dumelle will prepare an Order.

Motion to extend time to file response to motion to dismiss in #76-84, Santa Fe Park was granted by a vote of 5-0. Motion to compel payment was referred to the Hearing Officer. Mr. Goodman will prepare an Order.

Motion to amend in #78-131, Lippman was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

An Order was adopted in #78-124, Bloomingdale on a motion to amend by Citizens Utilities by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to amend in #78-264, Kewanee was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to reconsider in #78-275, Grain and Feed Association et al. was denied by a vote of 5-0. Mr. Dumelle will prepare an Order.

#78-276, SCA Services was dismissed and Motion for protective order was dismissed as moot by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss in #78-193, Valley View was denied by a vote of 3-0. Dr. Satchell and Mr. Young abstained. Mr. Dumelle will prepare an Order.

An objection was filed in the matter of #78-274, Richland Foundry and a hearing was authorized by a vote of 5-0.

Amended petition was accepted in #78-115, Kelsey-Hayes and an Order adopted indicating that the 90 day time limit will run from date of filing of amended petition. The vote was 5-0, Mr. Dumelle will prepare the Order.

Request to waive hearing in #78-244, Village of Roselle was granted and the case will be assigned for decision.

In new cases these actions were taken by a vote of 5-0: ##78-288, Village of Woodlawn, additional information requested, Order by Mr. Dumelle; 78-289, Interlake, Inc., hearing authorized; 78-290, EPA v. Morris Coal, hearing mandatory; 78-291, Roper Appliance, additional information requested, Order by Mr. Dumelle; 78-292, Howell Asphalt, held for an Agency Recommendation; 78-293, EPA v. Ralston-Purina Co., hearing mandatory.

These cases were discussed and held to December 14 for further discussion or possible decision: ##78-14, Oscar Mayer; 78-41, Cargill; 78-98, Commonwealth Edison; 78-190, Shell Oil; 78-255, Southern Illinois Power; 78-259, Olin Corporation; R74-2, R75-5, Sulfur Dioxide.

An Opinion and Order was adopted by a vote of 5-0 in #78-260 Safari Campground.

Motion to withdraw objection in #78-216, Arlingdale Development was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Proposed Orders in R76-10, Special Waste Hauling and R77-13, Public Water Supply Amendments were authorized for publication and comment by a vote of 5-0.

An Order was adopted in R76-16, Blasting Noise by a vote of 5-0.

An Order was adopted in ##75-11, Republic Steel, 75-12, Metropolitan Sanitary District and 75-13, -44 Interlake which lifted prior stay Orders and ordered the cases to hearing. The vote was 5-0 and Mr. Goodman will prepare the Order.

R78-13, Proposed Amendment to Rule 203.1 Exceptions was authorized for publication and hearing by a vote of 4-1, Mr. Dumelle dissented. Dr. Satchell will prepare the Order.

R78-15, Proposed amendments to Air Regulations, Rule 203(g) was authorized for hearing and publication by a vote of 5-0. The Board then proposed an Order numbered R78-16 in the matter of Amendments to the Air Regulations, Rule 203(g) and consolidated it with R78-15 for purposes of hearing. The vote was 5-0, Mr. Goodman will prepare an Order.

A closed session was then held with Mr. George Wolff, Chief of the Environmental Control Division of the office of the Illinois Attorney General.

A closed administrative session was then held with Ms. Wiley to discuss salary and personnel matters.

Other matters not acted on as listed were ordered held for consideration on December 14.
