January 18, 1979 Chicago, Illinois

Opinions and Orders were adopted by a vote of 4-0 in these cases: ##77-238, Decatur; 78-248, Bodine Electric; R76-16, Blasting Noise (Opinion); 77-248, Rosenband; 78-199, Village of Norris; 78-56, Watuhiyi Waterworks; 78-86, Finton; 78-169, Village of Moweaqua; 78-198, Ken Ault; 78-224, City of Springfield; 78-286, Village of Hammond.

R78-6, Proposed Procedural Rules pertaining to SO<sub>2</sub> were adopted for publication and comment by a vote of 4-0.

Motion for leave to file response instanter and motion to withdraw complaint were granted in #76-248, Ashland Chemical by a vote of 4-0. Mr. Goodman will prepare the Order.

Motion to dismiss #77-237, Chrysler and R78-8, Petition for Regulatory Change by Chrysler was granted by a vote of 4-0.

Motion for stay in ##77-327, U.S. Steel was denied by a vote of 4-0. Mr. Goodman will prepare the Order.

Motion to dismiss ##77-288, Owens-Illinois was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to amend in #78-132, Millstadt was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to stay in #78-146, Glendale Heights was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

In #78-176, Marathon Oil, Motion for leave to file an amended recommendation was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to extend time to file recommendation in #78-274, Richland Foundry was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for leave to appear in #78-296, Peabody Coal was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to stay in #78-307, Union Electric was granted by a vote of 4-0. Mr. Young will prepare an Order.

An Order was entered in R74-2, R75-5, SO<sub>2</sub> Emissions on a motion for rehearing or clarification by a vote of 4-0. Mr. Goodman will prepare an Order.

An amended petition in #78-291, Roper Appliance was ordered held for an Agency recommendation.



In these new enforcement cases, hearings are mandatory: #79-2, EPA v. Gilchrist Community Improvement Corp; 79-3, EPA v. Village of Ridgway; 79-4, EPA v. Evergreen Bath & Tennis Inc.; 79-5, EPA v. Crossroads U.S.A.

In other new cases these actions were taken by a vote of 4-0: #79-6, General Motors Corp., hearing authorized; 79-7, Southern Illinois Power, construed as a motion in #78-255 and the number was stricken, Order by Mr. Goodman; 79-8, Cora Dick Corp., held for an Agency recommendation; 79-9, Beker Industries, request to appear and hearing authorized, Order by Mr. Goodman; 79-12, Southwestern Illinois Coal, held for Agency recommendation; 79-13, EPA v. James Athans et al., hearing mandatory.

All matters not disposed of as listed were ordered held for reconsideration on February 1, 1979.
