Minutes of Regular Board Meeting March 29, 1979 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ## 77-332, Crystal Lake; 78-181, John Boast; 78-311, Olin Corp.; 79-8, Cora Dock.

An Opinion and Order was adopted in #78-172, City of Hanover, by a vote of 4-1, Mr. Dumelle dissented.

A motion by IEPA to consolidate the proceedings in R78-10, R78-11 and R79-3 was granted by a vote of 5-0. Mr. Goodman will prepare the Order.

A proposed Order in R78-3,-4, Hydrocarbons was adopted for publication and comment by a vote of 5-0, Mr. Young concurred.

Proposed Interim Orders were adopted for publication and comment in R78-10, Particulate Emissions and R78-11, Fugitive Particulate Emissions by a vote of 5-0.

A proposed Interim Order was adopted for publication and comment in R79-3, AQS Amendments, Rule 103, Permit Conditions and Maintenance by a vote of 5-0, Mr. Dumelle concurred.

Mr. James Harrington for Interlake Inc. made a motion that a sentence be added to the preamble of the Interim Orders in R78-10, R78-11 and R79-3 stating that these proposed Orders are not to be submitted to the U.S. Environmental Protection Agency for approval or disapproval. He stated that this motion would be submitted in writing to the Board. Mr. Harvey Sheldon for the Can Manufacturers' Institute joined in the motion made by Interlake. The Board voted 4-0 to deny the motion; Mr. Werner abstained. The proceedings were transcribed.

Motion for consideration and decision in #76-80, Allaert,was denied and motion for extension of time to file brief granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for stay was granted in #77-25, Marquette, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to amend and add parties in #78-102, Dougherty,was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to amend in #78-129, Itasca was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

A notice of bankruptcy in #78-131, Prescrete, was construed as a motion to dismiss and denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to withdraw in #78-146, Glendale Heights, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for leave to file recommendation in #78-181, Boast was taken with the Opinion and Order (see decisions).

Letter requesting release from a condition of an Order in #78-191, Nestle, was construed as a motion and granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for continuance in #78-193, Valley View, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

In #78-239, SCM Corp., a response to motion to amend was construed as a motion to vacate Board Order of March 15, 1979 and granted by a vote of 5-0. Mr. Young will prepare an Order.

A Stipulation to dismiss in #78-294, Marathon Oil, was construed as a motion to withdraw and granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss or stay in #79-5, Crossroads, was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for stay of conditions in #79-6, General Motors, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss #79-22, Georgetown, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Objection having been withdrawn in #79-32, Stepan Chemical, the hearing was cancelled and the matter ordered placed on the agenda for decision by a vote of 5-0.

Motion to amend in #78-301, Airview, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

These cases were discussed and held for further discussion or possible decision on April 12, 1979: ## 77-17, Idlewild Country Club;77-275, Ralph Korte; 78-262, Price; 78-291, Roper Appliance; 78-30, Arthur Light.

Amended petitions in #79-39, Laclede Steel, and 79-45, Balmoral Racing, were ordered held for Agency recommendation. An amended petition in #79-40, A&G Coal, was held to April 12 for consideration.

In new cases these actions were taken by a vote of 5-0: ## 79-52, Forest Preserve Dist. v. E&E Hauling, hearing authorized; 79-54, Amoco Oil, held to April 12; 79-55, Interlake, hearing authorized; 79-56, Lissner, held for an Agency recommendation.

Hearings are mandatory in these new cases: ## 79-57, EPA v. John Barr; 79-58, EPA v. The Minerals Management Corp.; 79-59, EPA v. James Ralston; 79-60, EPA v. Illinois Tank & Truck.

In other new cases these actions were taken by a vote of 5-0: ## 79-61, Illinois Power, motion for stay granted and hearing authorized, Order by Mr. Dumelle; 79-62, Consolidation Coal, hearing authorized; 79-63, Stauffer Chemical, hearing authorized; 79-64, International Harvester, held for Agency recommendation; 79-65, Stauffer Chemical, hearing authorized; 79-66, Nicholas-Homeshield, hearing authorized.

Hearings are mandatory in these cases: ## 79-67, EPA v. Chicago-Joliet Livestock, and 79-68, EPA v. Maryville Colonial Nursing Home.

The Board determined that #79-69, Walker, was not a variance petition but should be referred to the IEPA as an application for a permit. The number was ordered stricken and Mr. Dumelle agreed to write a letter to the petitioner.

Proposed Water Quality Standards Amendments filed by IEPA were given the number R79-6 and authorized for hearing and publication by a vote of 5-0.

Proposed Water Quality Standards Amendments filed by Modine Mfg. were authorized for hearing and publication by a vote of 5-0. The number assigned was R79-8.

All matters not disposed of as listed were ordered placed on an agenda for April 12, 1979 for possible consideration.
