Minutes of Regular Meeting  
April 26, 1979 Chicago, Illinois

All Board Members were present save Mr. Werner who was ill.

Opinions and Orders were adopted in these cases by a vote of 4-0: ## 77-188, Hart-Burrows; 78-3, Village of Algonquin; 78-262, Archibald Enoch Price; 78-274, Richland Foundry; 78-308, A.E. Staley.

An Opinion and Order was adopted in #78-127, Georgetown, by a vote of 3-1, Mr. Dumelle dissented.

A final Order was adopted in R76-1, Water Pollution Regulation Amendments, Phosphorus, by a vote of 4-0.

An Order was adopted in #77-347, Commonwealth Edison's motion for modification, by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to dismiss in #78-93, Kazlauskas, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

An Order was adopted in #78-177, Celotex, on a motion for sanctions et al. by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to correct record in #78-210, PPG Industries, was granted by a vote of 4-0. Mr. Dumelle presented a proposed Order by Mr. Werner which was adopted.

The Board determined that no formal action was needed on two joint motions submitted in #78-241, Granite City Steel, and that they would be taken with the case.

A motion to dismiss in #78-254, Kamarasy, was granted by a vote of 3-0, Dr. Satchell abstained. Mr. Dumelle will prepare an Order.

A motion filed in #78-269, Borden, was construed as an amended petition and granted by a vote of 4-0. Dr. Satchell will prepare an Order.

Motion for continuance in #78-266, Kerr Glass, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for Supplement in #79-1, Borden, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to amend #79-24, De Soto, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to consolidate in #78-38 and #78-83, Interlake, was denied by a vote of 4-0. Mr. Goodman will prepare the Order.

Motion to extend time for filing a recommendation in #79-40, A&G Coal, was granted until May 3, 1979 only by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to withdraw request for hearing in #79-50, Urbana and Champaign Sanitary District, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motions to dismiss in #78-58, Minerals Management, were denied by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motions for specification of errors in #79-63 and #79-65, Stauffer Chemical, were granted by a vote of 4-0. Mr. Dumelle will prepare the Order.

Since an objection was filed in #78-64, International Harvester, a hearing was authorized by a vote of 4-0.

Motions for continuances in #78-193, Valley View, and #78-264, Kewanee, were granted by a vote of 4-0. Mr. Dumelle will prepare the Orders.

An amended petition in #78-296, Peabody Coal, was accepted for hearing; and amended petition in #79-43, American Hoechst, was authorized for hearing.

An Opinion and Order was adopted in #78-138, Salt Creek, by a vote of 3-0, Mr. Goodman abstained.

The regular meeting for July 5, 1979 will be cancelled and reset for July 12, 1979. The Board will meet every other Thursday from that date.
