

ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting  
May 24, 1979 Chicago, Illinois

All Board Members were present.

Bids for FY80 court reporting services were opened and read. The Board asked Ms. Wiley to summarize the plans and said they would announce a decision at 12:00 p.m.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##77-143, Giachini; 77-287, Industrial Coating; 77-339, Village of Cary; 78-38, Frye; 78-55, Knox Wrecking; 78-111, Village of Basco; 79-39, LaClede Steel; 79-46, Marion; 79-51, Commonwealth Edison; 79-85, Dept. of Transportation (Order only).

The Board voted 5-0 to vacate the action taken on May 10, 1979 in the matter of R77-12, Water Pollution Regulations Amendments, Docket A. Mr. Young will prepare an Order.

The Board then adopted an Opinion and Order in R77-12, Water Pollution Regulations Amendments, Docket A by a vote of 5-0.

In #76-6, Tarkowski, motions for relief to replace and for hearing were denied by a vote of 5-0. Mr. Goodman will prepare an Order.

A motion to vacate Order in #76-84, Santa Fe, was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time to respond to a motion to dismiss in #78-285, Commonwealth Edison, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for continuance in #78-299, Quincy Foods, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #79-63, Stauffer Chemical, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for extension in #79-65, Stauffer Chemical, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to amend in #79-76, S & L Sanitation, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to amend in #79-77, Randolph County et al, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order. In #79-38, Interlake, motion for transmittal was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension in #79-83, Interlake, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Since an objection was filed in #79-86, Borah, a hearing was authorized by a vote of 5-0.

An Order was adopted in #79-104, Interlake, regarding a motion to consolidate by a vote of 5-0. Mr. Goodman will prepare an Order.

Opinions and Orders were adopted in these cases by a vote of 5-0: #78-44, Beloit Grain; 78-234, Consolidation Coal.

An Opinion and an Order were adopted #79-45, Balmoral Racing, by a vote of 4-0. Dr. Satchell abstained.

An Interim Order was adopted in R75-8, Fuel Oil Amendments, by a vote of 4-0. Dr. Satchell abstained.

These cases were discussed and held to June 7, 1979 for further discussion or possible decision: ##73-252, Stuart Oil; 78-153, Carlstrom and Lockport Trucking; 79-56, Lissner Corp.; 78-283, -284, Southern Illinois Minerals; R76-7, Mine Wastes; R78-3,-4, Hydrocarbons.

An amended petition in #79-9, Beker, was accepted for hearing.

In new cases these actions were taken by a vote of 5-0: ##79-72, Travieso v. Highland Hills, hearing authorized; 79-105, Maple Hills Nursing Home, held for an Agency recommendation; 79-106, DuPont, hearing authorized and motion to appear granted, Order by Mr. Dumelle; 79-107, Bradley Heights Water System, held for an Agency recommendation; 79-108, Joe Knox, dismissed as inadequate, Order by Mr. Dumelle; 79-109, Savanna Army Depot, hearing authorized; 79-111, Continental Grain, hearing authorized; 79-112, Modine Mfg., hearing authorized.

Mr. Dumelle made several remarks regarding the upcoming budget session and the APCA conference.

Ms. Wiley was then asked to summarize the submitted court reporting bids. After some discussion the contract for FY80 court reporting services was awarded to Longoria and Goldstine Court Reporting Service.

All matters not disposed of as listed were ordered placed on an agenda for possible consideration on June 7, 1979.
