

ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting  
June 22, 1979 Chicago, Illinois

The Board met pursuant to notice given that the meeting would be held on this date rather than June 21, 1979 as originally scheduled.

All Board Members were present.

An Opinion and an Order were adopted in #73-252, Stuart Oil, by a vote of 4-1, Mr. Werner dissented.

Orders of dismissal were adopted in these cases by a vote of 5-0: ##77-301, American Hoechst; 78-119, Northern Petrochemical; 78-142, Ashland Chemical; 78-160, Goodrich. Mr. Dumelle will prepare the Orders.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##78-110, Farina and Brown Produce; 78-153, Carlstrom and Lockport Trucking; 78-230, E. Lynn Community, Mr. Dumelle and Mr. Werner concurred; 78-269, Borden Chemical; 79-3, Village of Ridgway (Interim Order); 79-40, A & G Coal; 79-88, Village of Sauget.

A Proposed Order was adopted for publication and comment in R78-10, Particulate Emissions by a vote of 4-1, Mr. Werner dissented.

Proposed amendments to the Procedural Rules (R79-9) were adopted for publication and comment by a vote of 5-0.

Motion to decide without hearing was granted in #78-109, Celotex, and the matter was set for decision on July 12, 1979 by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for oral argument in #78-296, Peabody Coal, was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to amend in #79-58, Minerals Management, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to strike in #79-61, Illinois Power, was ordered taken with the case by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion and Stipulation to extend time to file Agency Recommendation was granted in #79-73, Simmons, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for Stay of conditions in #79-87, Sauget, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for leave to file recommendation in #79-99, Caterpillar Tractor, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for continuance was granted in #78-301, Airview, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for extension of time was granted in #79-106, DuPont, by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time to file response to motion to dismiss and stay was granted in #79-26, Continental Grain, by a vote of 5-0. Mr. Dumelle will prepare an Order.

The amended petition filed in #79-82, Olney, was ordered held for an Agency recommendation by a vote of 5-0.

An Opinion and an Order were adopted in #78-98, Commonwealth Edison, by a vote of 4-0. Mr. Goodman abstained.

An Opinion and an Order were adopted in #79-89, Reynolds Metals, by a vote of 4-0, Dr. Satchell abstained.

Marquette Cement, hearing mandatory.

The Board held an administrative session with Ms. Wiley to discuss FY80 Hearing Officer contracts.

All matters not disposed of as listed were ordered held to July 12, 1979 for possible consideration.
