All Board Members were present.

Opinion and Orders were adopted in these cases by a vote of 5-0: ##75-13,-44, Interlake (Interim Order); 78-133, Murdale Water District; 78-296, Peabody Coal; 79-9 Beker Industries; 79-25, W.W. Sanitation; 79-150, International Minerals (Opinion only).

An Order was adopted in #79-131, Marquette Cement by a vote of 3-2, Mr. Werner and Mr. Young dissented. Mr. Dumelle will prepare the Order. The proceedings were transcribed.

A proposed Order in R78-2, Disaster Burning, was adopted for publication and comment by a vote of 5-0.

A proposed Opinion and Order was adopted for publication and comment in R79-9, Procedural Rules Amendments, by a vote of 4-1 Mr. Werner dissented.

A proposed Opinion was adopted for publication and comment in R78-1, Carbon Monoxide, by a vote of 5-0, Mr. Werner concurred.

Motion to reconsider in ##78-88,-225, Sundale Sewer, was denied by a vote of 3-2, Mr. Young and Dr. Satchell dissented. Mr. Goodman will prepare an Order.

Motion for reconsideration in #78-130, Joliet, was denied by a vote of 5-0. Mr. Young will prepare an Order.

Motion to dismiss certain parties was granted in 79-58, Minerals Management, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motions to compel in ##79-83, Interlake and 79-104, Interlake, were dismissed as moot by a vote of 5-0. Mr. Goodman will prepare the Orders.

Since several objections were filed in #79-165, J. Royden Peabody, a hearing was authorized.

An Order clarifying the prior Opinion and Order in #79-64, International Harvester, was adopted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time to respond to motion for remand in #79-6, General Motors, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to decide without hearing was granted in #79-138, Sanitary District of Rockford, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to defer decision in #79-146, Sahara Coal, was granted by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion to continue in #79-35, Chevy Chase, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to withdraw request for hearing in #79-171, Rossmoor, was allowed and ordered set for decision on October 4, 1979.

An Order was adopted in #79-101, Allied Chemical, by a vote of 5-0. An Opinion will be considered on October 4, 1979.
