MINUTES OF REGULAR BOARD MEETING
MARCH 6, 1980 CHICAGO, ILLINOIS

All Board Members were present.

Mr. Dumelle introduced Mrs. Joan Anderson, recently appointed to the Board.

Mrs. Anderson abstained on all actions taken by the Board.

Opinions and Orders were adopted by a vote of 4-0 in these cases: ## 77-157, Decatur Sanitary District et al, (Interim Order); 77-232, Lake-in-the-Hills Sanitary District; 79-59, James Ralston; 79-77, Randolph County Landfill; 77-204, Town of Normal, Mr. Dumelle concurred; 79-216, Stonefort; 79-217, Watson; 79-230, Stauffer Chemical; 79-261, Monmouth; 79-268, Riverton.

A Proposed Opinion was adopted in R76-14,-19, Forging Noise Regulations by a vote of 3-1, Mr. Dumelle dissented.

Motion to stay penalty in #76-80, Allaert Rendering, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #78-161, Getzen, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to stay and consolidate in #78-239, SCM, was denied by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to reconsider a prior Board Order in #78-240, Wood Dale was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to extend time to file briefs in #78-296, Peabody Coal, was granted by a vote of 4-0. Dr. Satchell will prepare an Order.

Motion for 90 day continuance was granted in #79-98, Lombard, by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to withdraw in #79-219, Dept. of the Navy, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for stay in #79-243, Illinois Power, was granted in part by a vote of 4-0. Dr. Satchell will prepare an Order.

Motion to defer decision and motion for more definite statement was denied in #79-266, U.S. Steel. A response was construed as an amended petition. The vote was 4-0, Mr. Goodman will prepare an Order.

An amended petition in #80-10, Feldkamp, was ordered held for an Agency recommendation.

Bacon's Farm, to be considered on March 20, 1980; 70-39, Admiral, dismissed, Order by Dr. Satchell; 80-40, EPA v. Artim Transportation and Donald Mayer, hearing mandatory; 80-41, Village of Lemont, dismissed, Order by Mr. Dumelle; 80-42, Kraft, hearing authorized.
