MINUTES OF REGULAR BOARD MEETING
APRIL 3, 1980 CHICAGO, ILLINOIS

All Board Members were present.

An Order was adopted in #75-13, Interlake, by a vote of 4-0, Mrs. Anderson abstained.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##78-135, Palos Park, Mr. Goodman and Mr. Dumelle concurred; 78-295, E. St. Louis, Mr. Dumelle concurred; 80-10, Feldkamp,; 80-16, CIPS; 80-20, CIPS; 80-25, CIPS; 80-34, Rantoul.

An Opinion and Order was adopted in #80-11, City of Morris, by a vote of 4-0, Mr. Werner abstained.

R78-9, AQS Amendments, was adopted by a vote of 4-1, Mr. Werner dissented.

An Opinion and Order was adopted in #78-131, Prestcrete, by a vote of 4-1, Mr. Werner dissented.

Motion to modify in #79-17, Idlewood, was construed as a new variance petition and additional information was requested. The vote was 5-0, Mr. Goodman will prepare the Order.

Motion to dismiss in #77-322, Waukegan, was granted by a vote of 5-0. Mr. Goodman will prepare the Order.

Motion to modify in #78-102, Dougherty, was granted by a vote of 5-0. Dr. Satchell will prepare the Order.

Motion to accept an amended complaint was granted in #78-214, Pontiac, and a hearing was ordered to be set within 60 days. The vote was 5-0, Mr. Goodman will prepare an Order.

An Order was entered on a motion for sanctions in #79-145, Celotex, by a vote of 4-0. Mr. Werner abstained. Mr. Goodman will prepare the Order.

Motion to continuance in #79-195, Borden, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for additional hearing in R77-15 et al., Sulfur Dioxide, was denied by a vote of 4-0, Mr. Werner abstained. Mr. Goodman will prepare an Order.

An Order was adopted in #80-24, General Electric, by a vote of 5-0. Dr. Satchell will prepare the Order.

Additional information was requested on an amended petition filed in #80-27, City of East Peoria. The vote was 5-0, Mr. Dumelle will prepare an Order.

R80-5, Volatile Organic Emissions Amendments, was authorized for hearing and publication by a vote of 5-0.

Mr. Dumelle announced that in addition to himself, Mr. Goodman and Mrs. Anderson would be scheduled in the next week for confirmation of their appointments by the legislature.

All matters not disposed of as listed were ordered placed on an agenda for possible consideration on April 17, 1980.
