MINUTES OF SPECIAL BOARD MEETING MARCH 2, 1989 CHICAGO, ILLINOIS

Pursuant to notice given the meeting was called to order at 2:00 p.m. All Board Members were present save Dr. Flemal who was absent.

An Agency motion for reconsideration of a January 5, 1989 Board Order was denied in #87-62, Riverside Laboratories, by a vote of 5-1. B. Forcade dissented. (JD)

An Order was adopted pursuant to a motion for reconsideration and to reinstate in #88-195, McLean County Disposal, by a vote of 6-0. (JTM)

A provisional variance was granted in #89-43, Shell Oil Company, by a vote of 6-0. (JM)

In R88-5 (A), Procedural Rules, a Proposed Rule, Second Second Notice, Proposed Opinion and Order was adopted by a vote of 6-0. (JTM)

An Order establishing a 21-day comment period in which any person may request the Board to determine whether or not an Economic Impact Study should be prepared in R88-14, Abbott Laboratories, was adopted by a vote of 6-0. (JD)

An Order determining that an Economic Impact Study was not necessary was adopted in R88-25, Havana CSO, by a vote of 6-0. (MN)

There being no further business the meeting was adjourned at 2:20 p.m.
