In R89-16, RACT Deficiencies, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 6-0. (JD)

An Order dismissing the proceedings in #89-128, IBP, Inc., was adopted by a vote of 6-0. (JM)

In R89-2, UIC Update, USEPA Regulations (July 1, 1988 through December 31, 1988), a Proposal for Public Comment, Proposed Opinion and Order was adopted by a vote of 6-0. (JA)

Petitioner's motion for extension of time to file its response to the Agency recommendation in #89-66, Village of North Aurora, was granted until October 13, 1989 by a vote of 6-0. (RF)
