An Opinion and Order was adopted in #90-13, ABC Rail Corporation, by a vote of 5-2. Messrs. J. Dumelle and J. Theodore Meyer dissented. (RF)

An Opinion and Order was adopted in #90-19, DuPage Plating Company, by a vote of 5-2. Messrs. J. Dumelle and J. Theodore Meyer dissented. (RF)

J.C. Marlin presented a draft Opinion and Order in #90-84, We-Toast Bread. J. Dumelle's alternative draft, which was seconded by J. Theodore Meyer for discussion purposes, failed to carry by a vote of 2-5 with J. Dumelle and J. Theodore Meyer for it and J. Anderson, B. Forcade, R. Flemal, J. Marlin and M. Nardulli against it. The Opinion and Order was then adopted by a vote of 5-2. J. Dumelle and J. Theodore Meyer dissented and J. Anderson concurred. (JCM)

An Opinion and Order was adopted in #90-93, ITW Magnaflux, by a vote of 5-2. Messrs. J. Dumelle and J. Theodore Meyer dissented. (JA)

An Opinion and Order was adopted in #90-107, Miller Power Fluid, by a vote of 5-2. Messrs. J. Dumelle and J. Theodore Meyer dissented. (JCM)

An Opinion and Order was adopted in #90-130, Borden Chemicals and Plastics, by a vote of 7-0. (BF)

Default Orders were adopted in these Administrative Citations by a vote of 7-0: ##90-82, Daniel Van Fleet; 90-83, John Moody.

Respondent's petition for review of a July 13, 1990 Default Order in #AC 89-115, City of St. Francisville, was denied by a vote of 7-0. (JCM)

Agency motion to reconsider and vacate an August 30, 1990 Opinion and Order in #AC 89-224, John Vander, was denied by a vote of 5-2. Messrs. J. Dumelle and B. Forcade dissented. (MN)

An Order closing the docket in #AC 89-268, William and Betty Jayne, was adopted by a vote of 7-0. (BF)

Agency motion for reconsideration of an August 30, 1990 Opinion and Order in #AC 89-304, G & M Wrecking, was denied by a vote of 6-1. B. Forcade dissented and J. Dumelle concurred. (JA)

Respondent's motion to exclude evidence was granted in #90-59, American Milling Company, by a vote of 7-0. (MN)

Petitioner's motion to stay was granted until December 31, 1990 in #90-86, Container Corporation of America, by a vote of 7-0. (JCM)

By a vote of 7-0, An Order directing Complainant to file its proof of service no later than November 6, 1990 or the Board will consider dismissing the matter for want of jurisdiction, was adopted in #90-103, J.D. Plating Works. (RF)

Agency motion to file Record Instanter was granted in #90-126, Marathon Petroleum, by a vote of 7-0. (JCM)
