Final Orders, Adopted Rules were adopted in these cases by a vote of 5-0: R78-15, Rochelle Site Specific, Mr. Dumelle and Mr. Werner concurred; R80-22, SO<sub>2</sub>, Mr. Dumelle and Mr. Werner concurred; R81-24, Olin Site Specific.

In R82-12, AQS, Lead, a Proposed Rule, First Notice order was adopted by a vote of 5-0.


