MINUTES OF SPECIAL BOARD MEETING
August 30, 1983 Chicago, Illinois

Board Members J. Dumelle, J. Anderson, J.T. Meyer and W. Nega were present. Chairman Dumelle called the meeting to order at 3:00 P.M. pursuant to notice given.

The Board then certified by a vote of 4-0 that the notice of special meeting given was reasonable and the notice requirements for a special meeting had been met.

Mrs. Anderson presented a Proposed Opinion and Order in #83-123, Olin Corporation v. EPA, for discussion. The Board voted 4-0 to deny the provisional variance and ordered that a copy of the Board's Opinion and Order in #82-60, SCA Chemicals v. EPA, also be served on the Petitioner.

After some discussion of a Proposed Opinion and Order for #83-102, Olin Corporation v. EPA, presented by Mrs. Anderson, the Board voted 4-0 to grant the variance. A request for non-disclosure in the same matter was granted.

The meeting was adjourned.
