MINUTES OF BOARD MEETING  
October 8, 1981 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: #77-322, Waukegan; 79-215, Popp & Logan; 80-56, O'Fallon; 80-181, Illinois Fruit, Mr. Goodman concurred; 81-37, Cargill (Interim Order); 81-104, Illinois Fruit, Mr. Goodman concurred; 81-120, Belvidere; 81-139, -140, -141, Illinois Department of Transportation (Orders only).

In regulatory matters these actions were taken by a vote of 5-0: R77-12, WQS Amendments, Docket D, Proposed Order, First Notice, Mr. Goodman concurred; R79-11, Particulate Amendments, Caterpillar, Final Order, Adopted Rule; R80-17, Illinois Power, Cooling Lakes, Final Order, Adopted Rule; R80-18, Procedural Rules Amendments, Proposed Rule, Second Notice and Proposed Opinion.

Motion to withdraw motion for reconsideration was granted in #79-134, Commonwealth Edison, by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for oral argument and to strike recommendation was denied in #81-15, Marquette, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Request for hearing was granted in #81-126, DuPage, by a vote of 5-0. Mr. Goodman will prepare an Order.

Letter filed in #80-215, Noble, was construed as a motion for reconsideration and denied by a vote of 5-0. Mrs. Anderson will prepare an Order.

An Order was adopted in #81-112, Citizens et al. v. Bledsoe et al., granting a motion for reconsideration, denying a motion to amend and construing the amended complaint as a new proceeding. The vote was 5-0, Mr. Dumelle will prepare an Order.
