## MINUTES OF SPECIAL BOARD MEETING OCTOBER 27, 1994 CHICAGO, ILLINOIS

Pursuant to notice given, Chairman Manning called the meeting to order, and asked the Clerk for a roll call. All Board Members answered present. Board Member Joseph Yi abstained from participating in the decision or discussion of any matter on the Agenda.

An Opinion and Order was adopted in #AC 93-42, Norman Clark & Brenda Bertrand, by a vote of 4-2. Board Members R.C. Flemal and J. Theodore Meyer dissented, and Chairman C.A. Manning and Board Member M. McFawn concurred. (GTG)

An Opinion and Order was adopted in #94-138, Continental Waste Industries of Illinois, Inc., by a vote of 6-0. Board Member J. Theodore Meyer concurred. (ED)

An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$10,000.00, was adopted in #94-242, People of the State of Illinois v. Central Lake County Joint Action Water Agency, by a vote of 6-0. Board Member J. Theodore Meyer concurred.

An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$300.00, was adopted in #94-249, People of the State of Illinois v. Village of Rock City, by a vote of 6-0.

An Order granting the Respondent's motion to withdraw its petition for review, vacating the Order issued on October 6, 1994, and unless already paid, directing the Respondent to pay, within 30 days of the date of the Order, a penalty in the amount of \$1,000.00, was adopted in #AC 94-56, EPA v. Walter J. Griminger, d/b/a Land of Lincoln Motel, by a vote of 6-0. (JTM)

An Order, striking the Respondent's October 18, 1994 motion, pursuant to the Board's procedural rule at 35 Ill. Adm. Code 101.107(a)(2), which prohibits corporations from appearing in an enforcement action by a non-licensed attorney, was adopted in #94-272, People of the State of Illinois v. Allied Metal Company, by a vote of 6-0. (RCF)

This regulatory matter was discussed and ordered held to November 3, 1994 for further discussion or possible decision: R93-13, Petition of General Motors Corporation, Proposed Rule, Second Notice, Opinion and Order.

Amended Petition #94-262, Concerned Citizens of Williamson County, was accepted by the Board and the 120-day decision timeclock was restarted with its filing.

In new cases these actions were taken by a vote of 6-0: ##94-301, People of the State of Illinois v. Colfax Corporation, Clerk of the Board was directed to cause publication of the required newspaper notice of the parties' request for relief from the hearing requirement, Order; 94-302, The Alter Group v. The Lake County Board and USA Waste Services, Inc., accepted for hearing, Order; 94-303, Rawlings Towing, Inc. v. EPA, provisional variance granted, Order by C.A. Manning; 94-304, Tahoe Mobil, Inc. v. EPA, provisional variance granted, Order by C.A. Manning.

There being no further business, the meeting was adjourned.
