#### MINUTES OF SPECIAL BOARD MEETING JANUARY 19, 1995 CHICAGO, ILLINOIS

Pursuant to notice given, the meeting was called to order at 11:20 a.m. Chairman Manning apologized for the late starting of the meeting, and announced that in addition to those meetings already scheduled for the third Thursday of each month, weekly meetings will be held on each of the Thursdays remaining between January 26, 1995 and March 30, 1995, to deal more expeditiously with matters before the Board. The dates are: January 26; February 2, 9, and 23; March 2, 9, 23, and 30, and will be published in the Board's Environmental Register.

Chairman Manning asked the Clerk for a roll call, and all Board Members answered present save Board Member Dr. Ronald C. Flemal, who was absent due to illness.

Regulatory matter, R94-21, ROP Plan Control Measure for VOM Emissions, was discussed and held to January 26 or February 16, 1995 for further consideration.

An Interim Opinion and Order was adopted in #AC 94-8, IEPA v. Atkinson Landfill Company, by a vote of 6-0. (GTG)

An Opinion and Order was adopted in #94-262, Concerned Citizens of Williamson County, by a vote of 6-0. Board Members J. Theodore Meyer and M. McFawn concurred. (GTG)

An Opinion and Order was adopted in #94-276, The City of Batavia, by a vote of 6-0. (GTG)

An Order denying the Respondent's motion to reconsider a September 15, 1994 Default Order was adopted in #AC 94-67, IEPA v. Kirk Dana, by a vote of 5-0. Board Member J.C. Yi abstained. (CAM)

Because a Petition for Review was received, this Administrative Citation will be set for hearing: #94-98, Will County v. CDT Landfill.

A Default Order was adopted in this Administrative Citation by a vote of 6-0: 94-99, County of Vermilion v. Brickyard Disposal & Recycling, Inc.

An Order accepting the parties' joint status report, and directing all future status reports to be filed at the discretion of the Hearing Officer, was adopted in #93-3, Archer Daniels Midland, by a vote of 6-0. (CAM)

An Order granting the Petitioner's voluntary motion to dismiss its petition for review, was adopted in #94-167, Melrose Partners, by a vote of 6-0. (GTG)




