#### MINUTES OF REGULAR BOARD MEETING JUNE 1, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Chairman Manning welcomed members of the public and staff members. Thereafter, the Clerk was asked for a roll call and all Board Members answered present.

Minutes of the May 18, 1995 Board Meeting were approved by a vote of 6-0. Board Member J. Yi abstained.

Minutes of the May 25, 1995 Board Meeting were approved by a vote of 4-0. Chairman Claire A. Manning and Messrs. R.C. Flemal and G. Tanner Girard abstained.

In R95-4, -R95-6, UIC Update, USEPA Regulations (July 1, 1994 through December 31, 1994) and RCRA Subtitle C Update, USEPA Regulations (July 1, 1994 through December 31, 1994), an Adopted Rule, Final Order, Opinion and Order were adopted by a vote of 7-0. Board Member M. McFawn concurred. (ED)

An Order granting the Agency's motion for an extension of time until September 30, 1995 to file the Agency's recommendation, was adopted in #AS 94-18, Petition of Central Can Company for an Adjusted Standard from 35 Ill. Adm. Code Part 218, by a vote of 7-0. (MCF)

An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$15,000.00, was adopted in #94-201, People of the State of Illinois v. Becker Brothers, Inc., and G. Raymond Becker, Jr., by a vote of 7-0. Board Member J. Theodore Meyer concurred. (McF)

An Opinion and Order accepting the Stipulation and Proposal for Settlement Agreement in the amount of \$15,000.00, was adopted in #95-139, People of the State of Illinois v. MBL (USA) Corporation, by a vote of 7-0. Board Member J. Theodore Meyer concurred.

An Opinion and Order accepting the revised Stipulation and pursuant to that agreement finding respondent Rochelle Disposal Service in violation of Section 21(0)(5) and (12) of the Act and assessing the statutory penalty of five hundred dollars for each alleged violation, for a total of \$1,000.00, was adopted in #AC 94-37, County of Ogle v. City of Rochelle and Rochelle Disposal Service, Inc., by a vote of 7-0. Board Member J. Theodore Meyer concurred. (JY)

An Order granting the complainant's motion to modify and vacating and replacing the Board's April 20, 1995 Order that directs the respondent to pay the assessed penalty to the Sangamon County Department of Public Health, was adopted in #AC 94-76, Sangamon County v. SLC of Springfield, Inc., by a vote of 7-0. (JY)

An Order granting the respondents' motion to withdraw its petition for review, and unless already paid, directing the respondents to pay a \$500.00 penalty within 30 days of the date of the order, was adopted in #AC 94-94, IEPA v. Wayne D. Alberts and Sharon J. Alberts, by a vote of 7-0. (JY)

An Order denying the complainant's motion to dismiss respondent Orville Bartels' petition for review, was adopted in #95-26, IEPA v. Orville Bartels and Frank Blair, by a vote of 7-0. (JTM)

A Default Order was adopted in #AC 95-27, IEPA v. Browning-Ferris Industries, by a vote of 7-0.

A Default Order was adopted in #AC 95-30, IEPA v. Knox County Landfill Committee, by a vote of 7-0.

An Order granting the petitioner's motion to consolidate, was adopted in ##94-243, - 306, - 307, - 308, - 309, 95-133, - 134, ESG Watts, Inc. v. IEPA, by a vote of 7-0. (GTG)

An Opinion and Order granting the petitioner's motion to dismiss, directing the parties to effectuate their agreement, and incorporating the letters of May 5, 1995 and May 10, 1995 between the parties expressing the terms of the settlement, and advising the petitioner that the Board cannot grant the petitioner the right to refile its petition for review since appeals can only be filed within 35 days of the Agency's Determination, was adopted in #94-312, Spraylat Corporation v. IEPA, by a vote o 7-0. (ED)

An Order granting the petitioner's motion to withdraw and closing the docket, was adopted in #95-39, W.R. Grace - Connecticut, Grace Constructio Products v. IEPA, by a vote of 7-0. (GTG)

An Order granting the Agency's motion for an extension of time until September 1, 1995 to file the Agency's recommendation, was adopted in #95-90, Minnesota Mining and Manufacturing Company v. IEPA, by a vote of 7-0. (CAM)

An Order granting the respondents' unopposed motion for an extension of time until June 14, 1995 in which to file an answer, was adopted in #95-91, People of the State of Illinois v. Bell sports, Inc., Waste Hauling Landfill, Inc., and Waste Hauling, Inc., by a vote of 7-0. (CAM)

An Order staying the proceedings and directing the parties to file all future status reports with the hearing officer beginning with the next joint status report no later than August 31, 1995, was adopted in #91-49, LTV Steel Company v. IEPA, by a vote of 7-0. (RCF) An Order accepting the petitioner's status report in response to a March 2, 1995 Board Order, and directing the filing of two new status reports to be filed with the Board and the hearing officer, on or before August 31, 1995 and November 30, 1995, was adopted in #93-17, Phibro-Tech, Inc., formerly Southern California Chemical Company, a division of CP Chemicals, Inc., by a vote of 7-0. (RCF)

An Order finding that the complaint is neither frivolous or duplicitous and accepting the matter for hearing, was adopted in #95-144, Oscar M. Cohn v. Wesley United Methodist Church, by a vote of 7-0. (McF)

An Order accepting the matter for hearing, was adopted in #95-150, Marathon Oil Company v. IEPA, by a vote of 7-0.


