MINUTES OF REGULAR BOARD MEETING OCTOBER 19, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Chairman Manning welcomed members of the public and staff to the meeting. Thereafter, the Clerk was asked for a roll call, and all members answered present.

Minutes of the October 5, 1995 Board meeting were approved by a vote of 7-0.

In R95-20, RCRA Subtitle C Update, USEPA Regulations (January 1, 1995 through June 30, 1995), a Reason for Delay Order was adopted by a vote of 7-0. (ED)
