In R96-8, UIC Update, USEPA Regulations (July 1, 1995 through December 31, 1995), a Proposed Rule, Dismissal Order, was adopted by a vote of 7-0. (ED)

In R96-11, UST Update, USEPA Regulations (July 1, 1995 through December 31, 1995), a Proposed Rule, Dismissal Order, was adopted by a vote of 7-0. (McF)

An Order requesting additional information, was adopted in #AS 96-7, Petition of the City of Belleville, Illinois for an Adjusted Standard from 35 Ill. Adm. Code 106.705, by a vote of 7-0. **(ED)**




