MINUTES OF REGULAR BOARD MEETING
August 28, 1975 Chicago, Illinois

All Board Members were present save Mr. Goodman and Mr. Zeitlin who were on vacation.

Opinions and Orders were adopted in these cases by a vote of 3-0:##75-38, Monmouth; 75-241, City of Silvis.

An Opinion and Order was adopted in R74-14, Motor Racing Noise by a vote of 3-0.

Proposal filed by the Illinois EPA on August 11, 1975 in Motor Racing was ordered to be renumbered (R75-11) and authorized for publication and hearings.

R75-7, Water Quality Standards Amendments, Fish Toxicants, was ordered to be published in the Environmental Register for public comment until September 29, 1975.

An Order was adopted in ##73-211, International Harvester and 75-270, International Harvester by a vote of 3-0 on motions to dismiss. Mr. Dumelle will prepare the Order.

Motion to reinstate in #74-226, Collier Carbon was granted by a vote of 3-0. Mr. Dumelle will prepare the Order.

Motion to dismiss in #75-120, Larsen et al was granted by a vote of 3-0. Mr. Dumelle will prepare the Order.

An Order was adopted in ##75-180 and 75-283, Glendale Heights on motion for reconsideration of consolidation by a vote of 3-0 granting reconsideration. Mr. Dumelle will prepare the Order.

Motion to withdraw objection in #75-222, Illinois Central R.R. was granted and the hearing was cancelled. by a vote of 3-0. Mr. Dumelle will prepare the Order.

Motion to dismiss in #75-255, Village of Secor was granted by a vote of 3-0. Mr. Dumelle will prepare the Order.

An Order on a motion to dismiss in #75-283, Enders v. Glendale Heights was adopted by a vote of 3-0. Mr. Dumelle will prepare the Order.
