MINUTES OF REGULAR BOARD MEETING September 4, 1975 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in the following cases by a vote of 4-0: ## 74-140, Western Piece Dyers; 75-51, E. Lawn Water Co.; 75-174, Ashland Chemical (Interim Order); 75-178, Mason & Meents (Interim Order); 75-184, John Prior; 75-212, R. Fox; 75-243, Bee Chemical; 75-303, Peterson/Puritan; R74-13, Air Quality Standards Amendments, Flares.

An Opinion and Order was adopted in #74-469, Deere & Co. by a vote of 3-0. Mr. Henss took no part in the discussion or decision of the matter.

R74-10, Motor Vehicle Noise was authorized for public comment by a vote of 3-1. Mr. Henss dissented.

A Supplemental Order setting the wording of the rule change was adopted in R74-14, Motor Racing Noise by a vote of 3-0. Mr. Zeitlin abstained.

In #71-4, Fry Roofing, petition for rehearing was denied by a vote of 3-1, Mr. Henss dissented. Mr. Dumelle will prepare the Order.

A motion to dismiss in #74-443, Ferguson & Lange was ordered taken with the case by a vote of 4-0. Mr. Goodman will prepare the Order.

Motion to reinstate in #74-471, Johnson et al was granted by a vote of 4-0. Mr. Goodman will prepare the Order.

Motion for order in #75-107, Winnetka was denied by a vote of 4-0. Mr. Goodman will prepare the Order.

Motion to strike Agency recommendation in #75-154, Celotex was denied and the case was authorized for hearing by a vote of 3-0, Mr. Henss abstained. Mr. Dumelle will prepare the Order.

Conditional non-disclosure was granted on motion by petitioner in #75-268, Sherwin-Williams by a vote of 4-0. Mr. Henss will prepare the Order.
