MINUTES OF REGULAR BOARD MEETING
November 6, 1975 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 4-0 in these cases: #74-223,-229, North Shore Sanitary District, Mr. Dumelle will file a concurring statement; 75-110, Illinois Power; 75-126, Collins Improvement; 75-180, Glendale Heights; 75-207, Abitibi; 75-247, Federal Paperboard; 75-352, Southern Illinois Power.

Opinions and Orders were adopted in these cases by a vote of 3-1, Mr. Dumelle dissented: #75-265, Rock Island; 75-336, Amoco Oil Co.

Motion for reconsideration was denied in #72-79, Sangamo by a vote of 4-0. Mr. Zeitlin will prepare an Order.

Motions to dismiss in #74-471, Johnson et al were denied by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion for continuance was granted in #74-475 and 75-35, General Motors for 60 days by a vote of 4-0. Mr. Dumelle will prepare an Order.

In 75-28, Medinah a response to recommendation was considered only a response and no action was taken.

Motion for continuance was granted in #75-154, Celotex by a vote of 4-0. Mr. Zeitlin will prepare an Order.

Motion to file amended complaint in #75-239, Frieder was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to withdraw petition in #75-246, SIU was granted by a vote of 4-0. Mr. Dumelle will prepare the Order.

Motion for continuance and motion to dismiss in #75-271, International Harvester were both denied by a vote of 4-0. Mr. Goodman will prepare the Order.

Third-Party complaint was allowed in #75-284, Harrisburg Coal by a vote of 4-0. Mr. Zeitlin will prepare the Order.

Motion to reconsider in #75-351, Crews was ordered held one month.

#75-362, People v. Wheaton Sanitary District was dismissed by a vote of 3-1. Mr. Dumelle dissented. Mr. Zeitlin will prepare the Order.

Motions to dismiss in #75-368, Lincoln Stone were denied by a vote of 4-0. Mr. Goodman will prepare the Orders.

Motion to reconsider in #75-372, Benld was ordered held for one month.

Motion to dismiss in #75-380, CBE v. White Septic Disposal was denied by a vote of 3-0. Mr. Goodman abstained and Mr. Dumelle will prepare the Order.

In #75-421, Monsanto motion to consolidate with ##75-330,-331, Monsanto was granted by a vote of 4-0. Mr. Zeitlin will prepare the Order.

In #75-345, American Foundry, motion for hearing was granted and motion to dismiss denied by a vote of 4-0. Mr. Dumelle will prepare the Order.

A hearing was authorized in #75-355, Woodruff & Edwards by a vote of 4-0. Mr. Goodman will prepare the Order.

A hearing was authorized in #75-370, City of Chicago by a vote of 3-0. Mr. Zeitlin abstained from the discussion and decision to hold a hearing. Special 30 day legal notice to be given.
#75-138, Galena was dismissed by a vote of 4-0. Mr. Dumelle will prepare the Opinion and Order.

#75-214, Olin was dismissed by a vote of 4-0. Mr. Goodman will prepare the Opinion and Order.

An Opinion and Order was adopted in #75-269, Blakeslee-Midwest by a vote of 4-0. The Board took note in the Opinion that request to decide without a hearing was granted.

The Board asked the Clerk to call petitioner in #75-250, Springfield Sanitary District and request a two week waiver of decision time.

The Board voted to cancel the regular meeting scheduled for December 25, 1975 due to the holiday and to reschedule the regular meeting of January 1, 1976 to December 30, 1975 due to the holiday.

Minutes of Board Meeting held October 16, 1975 were approved by a vote of 4-0.

The Board voted 4-0 to give notice that newspaper notice of variance hearings would no longer be given effective as of the next published newsletter.

Del Monte Corp., hearing mandatory; 75-428, Lake Sara, held for an Agency recommendation; 75-429, Krenz Trucking, additional information requested by a vote of 4-0, Order by Mr. Dumelle; 75-430, Lincoln Developmental Center, additional information requested by a vote of 4-0, Mr. Dumelle will prepare an Order.
