MINUTES OF REGULAR BOARD MEETING  
January 29, 1976 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0:##  
75-157, AAA Disposal; 75-188, Metamora Industries; 75-226, Arvey  
Corporation; 75-325, CIPS Co.; 75-349, International Harvester; 75-366,  
Township of Leyden; 75-449, DeSoto.

An Opinion in support of a previously adopted Order was adopted in #  
75-347, Waltonville by a vote of 3-0, Mr. Young and Dr. Satchell abstained.

The Board adopted Orders in ##75-450 and 76-16, Illinois Department of  
Transportation authorizing Mr. Dumelle to sign permit applications. The  
vote was 4-0, Dr. Satchell abstained.

An Order was entered in ##72-63 and 72-153, Consolidation Coal on a  
petition for termination. The vote was 3-0, Mr. Young and Dr. Satchell  
abstained. Mr. Dumelle will prepare an Order.

On a joint motion for non-disclosure in #75-100, Commonwealth Edison,  
an Order was adopted by a vote of 5-0. Mr. Goodman will prepare the Order

Joint motion to reopen the record in #75-129, Farmington was granted  
by a vote of 4-0, Dr. Satchell abstained. Mr. Dumelle will prepare an Order.

Motion for leave to amend in #75-411, Rock Island was granted by a vote  
of 4-0, Dr. Satchell abstained. Mr. Young will prepare an Order.

Motion to dismiss in #75-459, Modern Plating was granted by a vote of  
4-0. Mr. Zeitlin will prepare an Order.
