#74-355, Arnold v. Gordon was dismissed on the Board's motion by a vote of 3-0, Dr. Satchell abstained. Mr. Goodman will prepare an Order.

Motion to return exhibits in #74-415, Wauconda was granted by a vote of 3-0, Dr. Satchell abstained. Mr. Zeitlin will prepare an Order.

Motion to consolidate in ##75-191 and 76-15, Western Mining was granted by a vote of 3-0, Mr. Young abstained. Dr. Satchell will prepare an Order.

Interlocutory appeal in #75-283, Enders v. Glendale Heights was denied by a vote of 3-0, Dr. Satchell abstained. Mr. Goodman will prepare an Order.

Motion to dismiss in #75-285, Bingham was ordered taken with the case by a vote of 3-0, Dr. Satchell abstained. Mr. Young will prepare an Order.

An Order was entered in #75-397, Midland-Ross noting that a motion for relief filed by the Agency was now moot. The vote was 3-0, Mr. Goodman abstained. Mr. Young will prepare an Order.

Petition to intervene in #75-440, Landfill, Inc. was dismissed as moot by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #75-503, Stepan Chemical was denied by a vote of 3-0, Mr. Young abstained. Mr. Zeitlin will prepare an Order.
