MINUTES OF REGULAR BOARD MEETING
June 18, 1976 Chicago, Illinois

All Board Members were present.

Motion for reconsideration in #75-111, Allied Chemical was denied by a vote of 5-0. Mr. Goodman will prepare the Order.

Joint motion to dismiss in ##75-142,-149,-169, Ford Motor Co. was granted by a vote of 5-0. Mr. Zeitlin will prepare the Order.
