MINUTES OF REGULAR BOARD MEETING  
October 28, 1976 Carbondale, Illinois

All Board Members were present.

The Board adopted Opinions and Orders by a vote of 5-0 in these cases: #74-404, Modern Utilities; 75-267, Terminal R.R. An Order in #76-222, International Harvester was adopted by a vote of 5-0 on the matter of a stipulation. Mr. Goodman will prepare the Order.

An Order was adopted in #74-410, Philadelphia Quartz in the matter of an interlocutory appeal by a vote of 5-0. Mr. Zeitlin will prepare the Order.
