MINUTES OF REGULAR BOARD MEETING January 6, 1977 Chicago, Illinois

Motion for stay in #74-480, 48 Insulations was granted as to penalty only by a vote of 4-0. Mr. Dumelle will prepare the Order.

Motion for stay in #75-218, Epperson et al was denied except as to penalty by a vote of 4-0. Dr. Satchell will prepare the Order.
